## **SUB: Bagging of 90 MW Solar Power Project**

Sir/Madam,

In compliance with Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, we inform you that SJVN Green Energy Limited ("SGEL"), a wholly owned subsidiary of the Company, participated in the Tariff based competitive Bidding process of Omkareshwar Floating Solar Park Phase-II (300 MW) conducted by REWA Ultra Mega Solar Limited (RUMSL) and bagged the full quoted capacity of 90 MW (Unit- B) Floating Solar Project @ ₹3.79/Unit on Build Own and Operate (BOO) basis through e-RA conducted on 08.08.2023.

The power purchase agreement shall be executed after issuance of LOI from RUMSL & MPPMCL. The Floating Solar Project (FSP) Project shall be developed by SGEL at the Omkareshwar reservoir, Madhya Pradesh through EPC contract.

Tentative cost of Construction / Development of this project is ₹610 Cr. The project is expected to generate 203 MUs in the 1<sup>st</sup> year and the cumulative energy generation over a period of 25 years would be about 4,781 MU. As per RfS the Project shall be commissioned in a period of 21 Months from the date of signing of PPA.

This is SGEL's 2<sup>nd</sup> Unit at Omkareshwar Floating Solar Park. SGEL is already developing the 90 MW (Unit-F) at Omkareshwar Floating Solar Park Phase-I. The commissioning of this Project is expected to reduce 2,34,304 Tonnes of carbon emission and would contribute in GoI mission of reduction in carbon emission.

Further, information as per SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated 13.07.2023 is enclosed.


