# सपादकीय

## राजकीय उलथापालथीचा काळ

महाराष्ट्र विधानसभा अध्यक्ष नाना पटोले यांनी गुरुवारी पदाचा राजीनामा दिला. यामुळे राज्यात राजकीय उलथापालथ होणार असल्याचे संकेत मिळाले आहेत. पटोले यांनी स्वतःच प्रदेशाध्यक्ष होण्याची तयारी दर्शवली होती. सध्याचे प्रदेशाध्यक्ष आणि महसूलमंत्री बाळासाहेब थोरात यांना दोन्ही पदांच्या घोड्यांवर मांड ठोकायची होती. त्यांनी महिनाभर दिल्लीत बसून पद जाऊ नये,म्हणून जोरदार लॉबिंगही केले. परंतु आता काँग्रेस श्रेष्ठींनी त्यांचा प्रदेशाध्यक्षपदाचा राजीनामा घेण्याचे ठरवले आहे, असे सांगितले जाते. त्यामुळे बाळासाहेबांचा एकाच वेळी दोन्ही पदे उपभोगण्याचा डाव उधळून लावला. प्रदेशाध्यक्ष पदासाठी काँग्रेसमध्ये जोरदार लॉबिंग सुरू होते. नितीन राऊत आणि विजय वडेट्टीवार यांचाही विचार त्या पदासाठी करण्यात आल्याचे सांगितले जाते. परंतु त्या दोघांचीही मंत्रीपदे सोडण्याची तयारी नव्हती. एकाच वेळेस दोन्ही पदे द्या, असे त्यांचे म्हणणे असल्याचे सांगितले जाते. एकदा काँग्रेसने एक व्यक्ति एक पद हे तत्व मान्य केल्यावर त्यावर पुन्हा विचार करण्याची काहीच गरज नाहि. परंतु काँग्रेसच्या महाराष्ट्रातील नेत्यांना सत्तेची कधी नव्हे ती ध्यानीमनी नसताना लॉटरी लागली असल्याने वाट्रेल त्या तडजोडी करू, पण सत्ता सोडायची नाही असा त्यांचा निश्चय आहे. त्यामुळे एकवेळ प्रदेशाध्यक्षपद नसले तरीही चालेल, परंतु मंत्रीपदे जाऊ नयेत, यासाठी या नेत्यांनी प्रदेशाध्यक्षपदावर पाणी सोडले. वास्तविक काँग्रेसची इतकी हलाखीची अवस्था होती की विधानसभा निवडणुकीला त्यांना उमेदवार मिळत नव्हते. ज्येष्ठ नेते पराभवाच्या भीतीने निवडणूक लढवण्यास तयार नव्हते. संकटाच्या काळात बाळासाहेब थोरातांनी पक्ष सांभाळला, असे सांगितले जाते. म्हणजे काय केले, ते त्यांनाच माहित. परंतु सत्ता असताना बाळासाहेबांना पक्षावरील पकड ढिली होऊ द्यायची नव्हती. तो बेत आता फसला आहे. आता पटोले यांचे नाव महाराष्ट्र प्रदेशाध्यक्ष म्हणून पुढील आठवड्यात जाहिर होण्याची शक्यता आहे.काँग्रेसचे दिवस इतके वाईट आले आहेत की एकेकाळी त्यांचाच मुख्यमंत्री असायचा आणि पक्षाध्यक्ष हा त्याच्या मार्गात काटे कसे पेरता येतील, याचाच विचार करत असे. विलासराव देशम ुख-मागरिट अल्वा, प्रभा राव वगैरे जोड्या या दृष्टिने गाजल्या होत्या. नंतर काँग्रेसला चाळीस जागा मिळणेही मुश्किल झाले. त्यामुळे आता त्यांना मिळेल त्या पदावर समाधान मानणे आणि जे मिळेल त्या पदासाठी लॉबिंग करणे नशिबी आले आहे. सध्या अनेक नव्या समीकरणांची चर्चा सुरू आहे. काँग्रेसला विधानसभा अध्यक्षपदाच्या मोबदल्यात उपमुख्यमंत्रिपद दिले जाईल, असे मानले जाते. परंतु काँग्रेसने मात्र आमची अशी काहीही मागणी नाहि, असे अधिकृतपणे सांगितले आहे. पडद्यामागून तशी सौदेबाजी सुरू असेल. मात्र ज्या महाविकास आघाडीत काँग्रेसला अत्यंत तिय्यम स्थान आहे,त्याच्या मागणीचा विचार केला जाईल, असे समजणे मूर्खपणाचे आहे. पटोले यांनी विधानसभा अध्यक्षपदाचा राजीनामा दिल्यानंतर लगेचच राष्ट्रवादी अध्यक्ष शरद पवार यांनी हे पद आता सर्वांसाठी खुले झाल्याचे म्हटले आहे. याचा अर्थ, काँग्रेसला सुखासुखी हे पद कुणीच मिळू देणार नाहि. सूत्र असे होते, की पटोले यांच्या राजीनाम्यानंतर आता हे पद काँग्रेसकडेच निर्विवादपणे जाईल. परंत् शरद पवार यांनी मध्येच खोडा घातला आहे. विधानसभा अध्यक्षपदासंबंधी महाविकास आघाडीच्या नेत्यांमध्ये चर्चा होईल, असे आता सांगण्यात येत आहे. याचा अर्थ बिनबोभाटपणे हे पद आता काँग्रेसला मिळू दिले जाणार नाहि. शिवसेनेला या सरकारमध्ये स्वतःचे असे काहीही म्हणणे नाहि. त्यामुळे त्यांच्या प्रतिक्रियेला काहीच अर्थ नाहि. मुख्यमंत्र्यांनी सरकार संपूर्ण स्थिर असताना पटोले यांनी राजीनामा देण्याची गरज नव्हती, असे म्हटल्याचे सांगितले जाते. सरकारच्या खुर्चीखाली या निमित्ताने हा लावलेला सुरुंग आहे, असे मानायला जागा आहे. नवीन विधानसभा अध्यक्ष कोण होणार, याकडे आता राज्याचे लक्ष आहे, पृथ्वीराजबाबा चव्हाण यांचे नाव आघाडीवर आहे. परंतु त्यांना राजीव सातव यांची जोरदार स्पर्धा आहे. शिवाय पवारांनी पृथ्वीराजबाबांच्या नावाला मान्यता दिली पाहिजे. पृथ्वीराजबाबा यांनी मुख्यमंत्रि असताना राष्ट्रवादीच्या शिखर बँकेतील साम्राज्याला हादरा दिला होता. तसेच पवार यांनी फायलींवर सह्या करताना लकवा मारतो का, अशी अप्रत्यक्ष टिकाही केली होती. त्या फायली कोणत्या विकासकामांच्या होत्या, हे पवारांनाच माहित असावे. परंतु यामुळे काँग्रेस आणि राष्ट्रवादीत ठिणगी पडली होती. आता त्याच पृथ्वीराजबाबांना पवार मान्यता देणार का, हा प्रश्न आहे. याचे कारण पृथ्वीराजबाबा हे निष्पक्षपाती आहेत. विधानसभेत ते उघड उघड़ सर्व निर्णय राष्ट्रवादीच्या कलाने घेतले जातील, हे पहाणार नाहित. त्यामुळे पवारांनी पृथ्वीराजबाबा यांच्या नावाला विरोध केला, तर त्यात आश्चर्य वाटू नये. खरे तर गेल्यावेळीही पृथ्वीराजबाबांचेही नाव विधानसभा अध्यक्षपदासाठी होते. परंतु ऐनवेळी काय कळ फिरली कोण जाणे. नाना पटोले यांना लॉटरी लागली. सूत्र काँग्रेसचाच या पदावर हक्क आहे, असे आहे. परंतु राष्ट्रवादी ते पद काँग्रेसला सुखासुखी मिळू देईल का, हा प्रश्न आहे. अर्थातच राजकारणात हे सारे चालत असते. येथे कुणीही राजा हरिश्चंद्र नाहि आणि साधुसंतही नाहि. त्यामुळे काँग्रेसलाच आपले पत्ते सावधपणे खेळावे लागतील. पटोले यांनी राजीनामा देऊन नव्या समीकरणांच्या नांदीचे संकेत मात्र दिले आहेत. कारण यातच भाजपचे ज्येष्ठ नेते सुधीर मुनगंटीवार यांनी मुख्यमंत्रि ठाकरे यांच्याशी बंद दाराआड चर्चा केली आहे. आता बंद दाराआड एकमेकांच्या कुटुंबाची ख्यालीखुशाली विचारण्यासाठी भेट होत नसते. मुनगंटीवार यांनी घेतलेली ठाकरेंची भेट आणि जे ठाकरे भाजप नेत्यांचे फोनही घेत नव्हते, त्यांनी आता मुनगंटीवार यांच्याशी केलेली चर्चा आणि इकडे पटोले यांचा राजीनामा या दोन गोष्टी एकत्रितपणे पाहिले त र खूप काही कळून जाईल.


