Hence this can not be the reason for increase/decrease in price and volume of the shares. On the contrary, the company on 23-03-2020 has informed your exchange/filed a letter in which it has been informed that company has stopped production activities with effect from 23-03-2020 due to the lockdown announced by the government.


