Notes:

- 1. Treasury transactions include transactions worth Rs. 5,739.92 crores between the Bank and State Bank of India that have been executed through CCIL NDS- Order Matching platform. Such transactions executed on CCIL NDS- Order Matching platform are excluded from the purview of omnibus limit, this is because at the point of dealing, the Bank does not have the knowledge of the counter party on the other side.
- 2. The Listing Regulations and the Companies Act, 2013, as amended from time to time, grants exemption from seeking approval of the Audit Committee for transactions entered into between the holding company and its wholly owned subsidiary company whose accounts are consolidated with such holding company and are placed before the shareholders at the general meeting for approval. Basis this, no omnibus approval was sought for transactions entered into with wholly owned subsidiary.
- 3. Represents payouts for the period April 1, 2023 to September 30, 2023 and includes fixed pay, perquisites, leave travel allowance, provident fund. Remuneration does not include stock options granted.
- 4. Amounts reported under the column "Value of related party transactions" in respect of 'Deposit with Bank' represents interest paid to the related parties. Once an account is opened, a bank cannot legally stop amounts coming into the customer's account and it is entirely up to the discretion of the customer how much amount it seeks to place into the deposit. Hence, for such current / savings account transactions no omnibus limit has been sought. In accordance with guidance note no. 20220425-30 on disclosure of Related Party Transactions issued by the Bombay Stock Exchange, we disclose that "acceptance of fixed deposits by the Bank is at the terms uniformly applicable/offered to all shareholders/public".
- 5. As per RBI circular DBR/2015-16/19 dated March 03, 2016, the Bank pays additional interest of 1 % per annum, over and above the rate of interest mentioned in the schedule of interest rates on deposits to all Bank staff.
- 6. As per the RBI Master Circular No. RBI/2015-16 /95 DBR. No. Dir. BC.10/13.03.00/2015-16 "Loans and Advances Statutory and Other Restrictions" dated July 1, 2015 transactions entered into with certain individuals, entities and their relatives needs to be monitored. Such individuals, entities and their relatives may not qualify to be a related party of the Bank as per the Bank's "Policy on dealing with Related Party Transactions". Accordingly, the same have been excluded for the purposes of half yearly exchange reporting of related party transactions.
- 7. As per the Annex to SEBI circular SEBI/HO/CFD/CMDI/CIR/P/2021/662 dated November 22, 2021, listed banks shall not be required to provide the disclosures with respect to related party transactions involving loans, inter-corporate deposits, advances or investments made or given by the listed banks.
- 8. Related party transactions, opening and closing balances where amounts are below INR 50,000 are denoted as "0.00"
