- (1) I, Sudhansu Sekhar Panigrahi, Practicing Company Sccretary (ACS 23187 /CP 19649) was appointed as Scrutinizer by the Company in connection with the 38th Annual General Meeting of the members of SMIFS Capital Markets Ltd (herein after called "Company") held on 25th September, 2021 through Video Conferencing ("VC")/Other Audio-Visual Means ("OVAM") at its registered office at Vaibhav, 4F, 4 Lee Road, Kolkata - 700 020 at 11.00 A.M. for the purpose of scrutinizing the e-voting and voting through physical ballots process in a fair and transparent manner and ascertaining the requisite majority for the said voting as per the provisions of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administrations) Rule, 2014 as amended on the resolutions referred to in this report.
