India Ratings and Research (Ind-Ra) is pleased to communicate IRB InvIT Fund's (IRB InvIT) Long-Term Issuer Rating / Bank Loan Ratings at 'IND AAA'. The Outlook is Stable. The bank wise facilities are mentioned in the Annexure while the overall facilities remain unchanged.
