The Board Meeting of the Company was held on 14<sup>th</sup> February, 2020. The Chairman of the Meeting has placed before the Board the Notice No. LIST/COMP/512099/Reg.6(1)-Mar-19/225/2019-20 dated 14<sup>th</sup> November, 2019 received from BSE Ltd. imposing fine of Rs. 31,000/- + 18% GST for non-appointment of Company Secretary as Compliance Officer of the Company as per Reg. 6(1) of the SEBI (LODR) Regulations, 2015 along with the reply filed on 16<sup>th</sup> November, 2019 requesting waiver of the said fine. The BSE Ltd. has rejected the request for waiver of fine.

The Board discussed, noted and provided the following response:

'The Company has availed the exemption for certain regulations of SEBI (LODR) Regulations, 2015 in the financial year 2018-19. The Company has decided to avail exemption under Regulation 15(2) of the SEBI (LODR) Regulations, 2015 in respect of Corporate Governance regulations for the financial year 2019-20 onwards.

The Board of Directors at its Meeting held on 01<sup>st</sup> August, 2019 appointed Ms. Jyoti Verma, (ACS 49657) as Company Secretary cum Compliance Officer of the Company w.e.f. 01<sup>st</sup> August, 2019 and intimated the same to BSE Ltd.

Ms. Jyoti Verma has resigned as Company Secretary cum Compliance Officer of the Company w.e.f.  $20^{th}$  January, 2020 and the same has been intimated to BSE Ltd.

Thereafter, The Board of Directors at its Meeting held on 24<sup>th</sup> January, 2020 has appointed Mr. Rohit Choudhary (ACS 56612) as Company Secretary cum Compliance Officer of the Company w.e.f. 24<sup>th</sup> January, 2020 and intimated the same to BSE Ltd.'
