Special teams to crack down on narcotics sale

EXPRESS NEWS SERVICE AHMEDABAD, JULY 1
GUJARAT DIRECTOR General of Police (DGP) Ashish Bhatia has asked senior police officers in the state to form special teams in each city and district to crack down on sale of illicit narcotics.
According to the DGP, these special teams will have selected officers from the special operations groups (SOGs) and Local Crime Branch (LCB) in each district/city. The Crime Investigation Department (CID) and Cyber Crime Cell have also been roped in to tackle the menace of sale/purchase of drugs through dark web.
As per a statement released by the office of Bhatia on Thursday, "A video conference was held between the DGP and senior police officials on Thursday in which the DGP has asked to make an action plan against illicit narcotics sale in Gujarat... Senior police officials have been asked to make special teams in each district and city... The teams will keep strict watch on areas where educational institutions are located and act against synthetic drugs... Help of trained dog squads will also be taken. The Anti Terrorist Squad (ATS) has also been asked to crack down on interstate and international smuggling of drugs."
The DGP has also instructed police to detail persons involved in the sale of illicit drugs in the past under provisions of the Narcotic Drugs and Psychotropic Substances (NDPS) Act.

Three die while cleaning sewer in Silvassa

Daman: Three workers died after inhaling toxic gases while cleaning a sewer line in Silvassa town of Dadra and Nagar Haveli and Daman and Diu on Thursday, an official said.
The incident took place in Ahrilhalla area around 12.45 pm, said sub-divisional magistrate R Sharma. The deceased were identified as Rajesh, Ishwar and Dharmik. He said, while Rajesh and Ishwar were natives of Dahod district, Dharmik belonged to Amreli district.
According to eyewitnesses, Rajesh entered the sewer first and immediately fell unconscious after inhaling toxic gases inside the sewer. Dharmik went in to rescue him, but they too collapsed. All three died on the spot. PTI
