**Notes to the financial results for the Quarter and nine months ended December 31, 2022:**

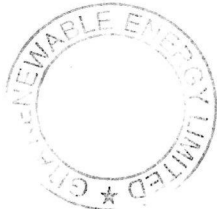
1. Previous period figures have been regrouped wherever necessary.
