These transfers shall be made simultaneously, and therefore his post-transfer shareholding shall be 0.01%.
- (**) As stated above, Mr Sajan Kumar Bansal is simultaneously undertaking acquisitions of shares and voting rights in Skipper, both directly (from immediate relatives) and indirectly (through the promoter companies), and accordingly his post-transfer shareholding shall be 21.29%. Mr Sajan Kumar Bansal has made a separate disclosure under Regulation 10 (5).
