1	Claimant: IRCTC Respondent: Brandavan Foods Pvt. Ltd., Satyam Caterers, R.K. Associates	An Objection petition u/s 34 of Arbitration & Conciliation Act has been filed agaisnt the Arbitral Award dated 27.04.2023 passed by Justice V.K. Gupta (Retd). As per the direction of the Hon'ble High Court in the said case between IRCTC and M/s. Brandavan Food Products Private Limited, IRCTC has been advised to deposit the bank guarantee of the total amount which is approx. 105.21 Crores as passed by the Ld. Arbitrator in lieu of the regular mode (cheque/online) of payment. The next date of hearing is slated for 17.11.2023.	Approx. 74.70 crores
2	Claimant: IRCTC Respondent: Govt. of NCT	VAT cases filed before Hon'ble Supreme Court on India was listed on 06.10.2017 and still pending adjudication, however the next date of hearing is not known.	Approx. 82.51 Crores
3	IRCTC	The matter were concluded and order from authority was awaited however, the National Anti Profiteering Authority (NAA) has lost jurisdiction to adjudicate upon the matter with a notification dated 23.11.2022 effective from 1.12.2022 and now Competition Commission of India (CCI) has been vested with powers to adjudicate. No communication received from CCI till date.	Approx. 50.41 Crores
4	IRCTC	IRCTC filed an appeal before the CESTAT which is under process. Meanwhile, In the financial year 2019-20. Constitutional validity of the services fall under the "Renting of immovable property" is challenged through a Special Leave Petition (SLP) by some other aggrieved assesses and the same had been admitted by the Apex court. The last hearing on the above mentioned show cause notice was held on 08.05.2019 and the same is adjourned sine die. Same will be taken up by the CESTAT after the decision of the Honorable Supreme Court in the above mentioned SLP.	Approx. 79.02 Crores
