1. Appointment as Scrutinizer:

I, Ragini Chokshi, Partner of M/s. 2. Our Responsibility

The management of the Company is responsible to ensure the compliance with the requirements of the Act, Rules and notifications and SEBI Listing Regulations relating to voting through electronic means on the businesses set out in the Notice of the EOGM of the Members of the Company. - iii) The Company completed dispatch of Notice of EOGM on Monday, February 20th, 2023 by E-mail to Members who had registered their email addresses with the Company / Depositories.

Voting rights were reckoned as on Tuesday, March 07, 2023 being the cut-off date for deciding the entitlements of members for remote e-voting and e-voting during the EOGM.
