Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with rule 20 of the Companies (Management and Administration) Rules, 2014, as amended and other applicable provisions of the Act and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company is providing its members facilities for remote e-voting. Members holding shares either in physical form or dematerialized form, as on the cut-off date of Monday, December 02, 2019 and may cast their vote electronically on the businesses set forth in the Notice of the EGM through the electronic voting system on National Securities Depository Limited (NSDL) from a place other than the place of venue of the EGM ("remote e-voting").

- The Special Business set forth in the Notice of the EGM may be transacted through remote e-voting.
  - The remote e-voting shall commence on Friday, December 06, 2019 (09:00 hrs. IST).
  - The remote e-voting shall end on Sunday, December 08, 2019 (17:00 hrs. IST).
  - The cut-off date for determining the eligibility for remote e-voting is Monday, December 02, 2019. Any person, who acquires shares of the Company and becomes member of the Company after the dispatch of Notice and holding as on the cut-off date, may obtain login ID and password by sending an email to evoting@nsdl.co.in. However, if a person is already registered with NSDL for remote e-voting, then existing user ID and password can be used for casting vote.
  - Members eligible to vote may note that: (a) The remote e-voting module shall be disabled by NSDL after 17:00 hrs. IST on Sunday, December 08, 2019 and once the vote on a resolution is cast by the member, the member shall not be allowed to change it subsequently; (b) The facility for voting through polling paper shall be made available at EGM; (c) The members who have cast their votes by remote e-voting prior to the EGM may also attend the EGM but shall not be entitled to cast their votes again; and (d) A person whose name is recorded in the register of members or in the register of beneficial owners maintained by the depositories as on the cut-off date only shall be entitled to avail the facility of remote e-voting of voting at the EGM through poll.
