I, Vijayakrishna KT, Company Secretary in Whole-Time Practice (FCS No 1788, CP No.980), having office at # 496/4, 2nd Floor, 10th Cross, Near Bashyam Circle, Sadashivanagar, Bangalore – 560 080, was duly appointed as Scrutinizer by the Company for the purpose of scrutinizing the Postal Ballot facility provided as per Sections 108 and 110 of the Companies Act, 2013 ('the Act'), read with Rule 20 and 22 of the Companies (Management & Administration) Rules, 2014 as amended from time to time ('the Rules') and the provisions of Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

My responsibility as a Scrutinizer is to ensure that the voting process is conducted in a fair and transparent manner and is restricted to make a Scrutinizer's Report for the votes casts in "favour" or "against" on the Resolution proposed in the Notice dated 11th February, 2020 based on the report provided by KFin Technologies Private Limited (*KFin*) (formerly Karvy Fintech Private Limited), the Agency engaged by the Company to provide e-voting facility and ballots received through post up to 24th March, 2020.

In terms of the aforesaid Notice and as per the provisions of the Act and the Rules, e-voting was kept open from 24th February, 2020 (9.00 A.M. IST) till 24th March, 2020

(5.00 P.M. IST) and Members were requested to cast their votes electronically conveying their assent or dissent in respect of the Resolution on the e-voting platform.

The details containing *inter-alia*, the list of the Members, who voted “for” or “against” on the Resolution that was put to vote, was derived from the Ballots received and the report generated from the e-voting website of KFin i.e. <https://evoting.karvy.com> and based on such reports,

- a. 122 members (folio wise) have cast their votes through remote e-voting.
- b. 42 members (folio wise) have cast their votes through Physical Ballot.

Votes by Shareholders who have voted part of their entitlements were taken accordingly.

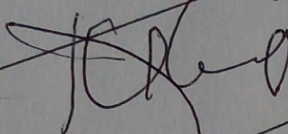
