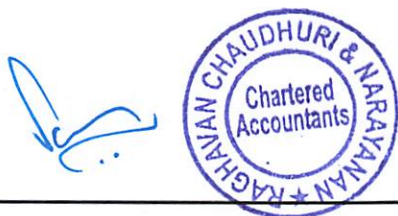

We have reviewed the accompanying statement of Unaudited Consolidated Financial Results of Sundaram Clayton Limited (the 'Parent Company'), and its subsidiaries (the Parent Company and its subsidiaries together referred to as "the Group"), and its share of the net profit after tax and total comprehensive income of its associates for the quarter ended 30th September 2021 and Consolidated year to date results for the period 1st April 2021 to 30th September, 2021 (the 'Statement') attached herewith, being submitted by the Company pursuant to the requirements of Regulation 33 and 52 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, as amended ("Listing Regulations").
2. Our responsibility is to express a conclusion on the Statement based on our review.
3. We conducted our review in accordance with the Standard on Review Engagement (SRE) 2410, 'Review of Interim Financial Information Performed by the Independent Auditor of the Entity' issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. A review is limited primarily to inquiries of company personnel responsible for financial and accounting matters, and applying analytical and other review procedures to financial data. A review is substantially less in scope than an audit conducted in accordance with Standards on Auditing and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. We did not review the interim financial information/financial results of the three subsidiaries, included in the unaudited consolidated financial results, whose interim financial information/financial results reflect total assets of Rs. 12,181.73 crores as at 30th September 2021 and total revenues of Rs. 5,790.63 crores and Rs. 9848.98 crores, total profit after tax of Rs.282.32 crores and Rs. 332.98 crores and total comprehensive income of Rs. 245.64 crores and Rs. 299.37 crores, for the quarter ended 30th September, 2021 and for the period from 01st April 2021 to 30th September 2021 respectively and cash outflows (net) of Rs. 94.50 for the period from 01st April 2021 to 30th September 2021, as considered in the unaudited consolidated financial results. The unaudited consolidated financial results also reflect the Group's share of net profit after tax amounting to Rs. 3.61 crores and Rs. 5.69 crores and Other Comprehensive Loss of Rs.0.10 crores and Rs. 0.12 crores for the quarter ended 30th September, 2021 and for the period from 01st April 2021 to 30th September 2021, respectively, from one associate whose interim financial information were not reviewed by us. These interim financial information / financial results have been reviewed by other auditor's whose report has been furnished to us by the management and our conclusion on the statement, in so far as it relates to the amounts and disclosures included in respect of these subsidiaries, is based solely on the reports of the other auditors and procedures performed by us as stated in paragraph 3 above.

Our conclusion on the statement is not modified in respect of the above matter.

6. The unaudited consolidated financial results include the interim financial information / financial results of Thirteen subsidiaries which have not been reviewed by their auditors and are based solely on management certified accounts, whose interim financial information / financial results reflect total assets of Rs. 3,144.96 crores as at 30th September 2021 and total revenues of Rs. 198.20 crores and Rs. 367.11 crores, total after tax losses of Rs.68.69 crores and Rs. 110.89 crores and total comprehensive loss of Rs. 79.38 crores and Rs. 100.68 crores, for the quarter ended 30th September, 2021 and for the period from 01st April 2021 to 30th September 2021, respectively, and cash inflows (net) of Rs. 56.35 crores for the period from 01st April 2021 to 30th September 2021 as considered in the unaudited consolidated financial results. The unaudited consolidated financial results also reflect the Group's share of Net Loss amounting to Rs. 1.70 crores and Rs. 2.99 crores for the quarter ended 30th September, 2021 and for the period from 01st April 2021 to 30th September 2021, respectively, as considered in the unaudited consolidated financial results from seven associates whose interim financial information were not reviewed by their respective auditors and are based solely on their management certified accounts.

Our conclusion on the statement is not modified in respect of the above matter.



7. Thirteen subsidiaries and four associates are located outside India whose financial information have been prepared in accordance with accounting principles generally accepted in their respective countries. The Company's Management has converted these financial information, to Indian Accounting Standards (Ind AS) prescribed under Section 133 of the Companies Act, 2013 and other accounting principles generally accepted in India from accounting principles generally accepted in their countries. We have reviewed these conversion adjustments made by the Company's Management. Our conclusion in so far as it relates to such subsidiaries and associate located outside India, is based on the aforesaid conversion adjustments prepared by the Company's Management and reviewed by us.

Our conclusion on the statement is not modified in respect of the above matter.

8. 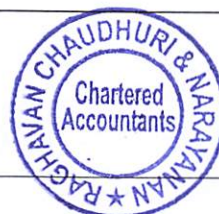
