# PROCEEDINGS OF THE 43<sup>RD</sup> ANNUAL GENERAL MEETING OF THE COMPANY HELD ON MONDAY, 07<sup>TH</sup> AUGUST, 2023

The 43<sup>rd</sup> Annual General Meeting ('AGM') of the Company was held on Monday, 7<sup>th</sup> August, 2023 at 9:00 A.M. at Wodehouse Gymkhana, 182, Maharshi Karve Road, Nariman Point, Mumbai – 400 021, Maharashtra, India to transact the business as set out in the Notice of the 43<sup>rd</sup> AGM dated 7<sup>th</sup> July, 2023.

The meeting commenced at 9:00 A.M. and concluded at 9.31 A.M.

# **Directors and Key Managerial Present:**

Mr. Bhavik R Bhimjyani, Chairman & Managing Director of the Company.

#### Quorum of the meeting:

Total 56 members (excluding proxies) attended the AGM.

# **Brief proceedings:**

Mr. Bhavik R Bhimjyani, Chairman & Managing Director of the Company informed the members that:

- The Company has received 6 proxies u/s 105 of the Companies Act, 2013;
- The Notice convening the 43<sup>rd</sup> AGM and the Annual Report containing the Audited Financial Statements of the Company for the financial yearended 31<sup>st</sup> March, 2023 along with reports of the Board of Directors and Auditors thereon and the relevant annexures have been circulated to the members of the Company through email within the statutory time period.
- With the permission of the members present, the notice of the AGM was taken as read.

- Since the Statutory Auditors' Report and Secretarial Auditors' Report did not contain any qualifications, reservations or adverse remarks or disclaimer, were not required to be read.

Mr. Bhavik R Bhimjyani took the Chair of the meeting. As the requisite quorum was present, the Chairman called the meeting to order. He welcomed the members present in the meeting.

Mr. Bhavik R Bhimjyani delivered his speech addressing the shareholders about performance of the Company during the financial year 2022-23.

The Chairman then presented the agenda items.

The Chairman informed the members present that:

As per the provisions of Section 108 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014 and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and Secretarial Standard on General Meetings (SS-2) issued by the ICSI, the Company had provided remote e-voting facility to its members to vote on resolutions placed in this  $43^{\rm rd}$  Annual General Meeting. He then informed the members that to facilitate the voting during the  $43^{\rm rd}$  AGM to the members present thereat and did not cast their vote earlier through remote e-voting facility, and who are present in the meeting will have an opportunity to cast their votes through polling papers in respect of items of business as set out in the Notice of the  $43^{\rm rd}$  AGM.
