We would like to draw your kind attention to the following:

- The physical transfer of shares has been discontinued from April 01, 2019 as per SEBI circular. The shareholders are further permitted to hold the Share Certificates in physical mode as long as they wish. However if you wish to transfer the shares, you are first requested to get shares dematerialized and then transfer the same in dematerialised form. Transmission, Name Deletion and Transposition of shares are permitted to be carried out in physical mode without any restrictions even after 31st March, 2019.
- As per the SEBI direction, un-encashed dividend amount is now to be directly credited into the Shareholder's bank account. Shareholders holding shares in physical mode are requested to submit duly signed request letter with original cancelled cheque leaf having their name printed on it along with copy of self-attested PAN card. Shareholders holding shares in dematerialized mode are requested to submit the request letter along with latest "Client Master Form" duly stamped and signed by an authorized person of Depository Participant.

Shareholders who have yet to register their email address are requested to do so with their Depository Participant (for those holding shares in electronic form) or with the Share Transfer Agent (for those holding shares in physical form), so that future communications would be in paperless form.
