# German state's PM quits amid fury over far rights

The premier of Germany's Thuringia state stepped down and called for snap elections Thursday, barely 24 hours after he was elected with the help of far-right AfD lawmakers in a vote Angela Merkel called "unforgivable".

Thomas Kemmerich, from the liberal Free Democrats (FDP), said he would apply for the regional parliament to be dissolved in response to the outrage over his appointment, which drew comparisons with the rise of the Nazis in the 1930s.

"We want new elections to remove the stain of the AfD's support from the office of the premiership," he told reporters, adding that his resignation was "unavoidable".



Kemmerich's election on Wednesday marked the first time in German post-war history that a state premier was heaved into office by accepting votes from the far right, crossing a red line in a nation haunted by its Nazi past.

He became the surprise winner of a run-off vote after AfD lawmakers ditched their own candidate to back

him, in what Kemmerich called "a perfidious trick" by the far right.

Chancellor Merkel earlier called the vote "unforgivable" and said the result "must be reversed".

She reiterated that her centre-right CDU would never work with the anti-Islam, anti-immigrant AfD, on a regional or national level.

# Obese owl set free after 'strict' dieting

An unusually fat owl flapped its wings and flew back to the wilderness after being put on a 'strict' diet by rescue workers from a British sanctuary.

The Suffolk Owl Sanctuary has informed in a Facebook post that the bird, which was found stuck in a ditch, had got too fat to fly after feasting on hoards of

field mice and voles that were running around in abundance due to a warmer winter in the area.

Fox News quoted KARE-TV which reported that the owl, which has been named Plump, tipped the scales at 245 grams, almost a third more than its peers of the same age and species.

Plump was then placed on a dieting regime and is now back to normal size.

# Terrorist behind attack on Malala escapes jail

Ehsanullah Ehsan, the former Pakistan Taliban spokesman who was responsible for the shooting of Malala Yousafzai in 2012 and carrying out the deadly Peshawar Army school terror attack in 2014, has escaped from prison, according to an audio clip released by him.

In the audio clip, which surfaced on social media on Thursday, Ehsan said that he escaped the confinement of Pakistani security agencies on January 11, claiming Pakistani forces failed to keep their promises made to him during his surrender in 2017.

"With the help of God, I succeeded to escape on January 11, 2020 from the confinement of the security forces," he is heard saying in the clip.
