The Company has received consents from constituents of Promoters viz. Welspun group companies being Welspun Steel Limited (“Welspun Steel”) and MGN Agro Properties Private Limited (“MGN Agro”) and other selected investors for subscribing to equity shares and/ or warrants carrying option to subscribe to equity shares of the aggregate amount of upto Rs.169,09,19,880 by offering the redeemable preference shares held by them in the Company for subscribing to securities proposed to be issued in the EOGM.
