# SC dismisses Lalu's bail plea in fodder scam

New Delhi, April 10

THE SUPREME COURT ON Wednesday dismissed Lalu Prasad Yadav's plea seeking bail in multi-crore fodder scam cases, dashing hopes of the BJP supreme for a conviction during the Lok Sabha polls.

The top court said Yadav was a convicted criminal and the plea filed by him in the bail was nothing in comparison to the 14-year sentence awarded to him. A bench of Chief Justice Ranjan Gogoi and Justices Deepak Gupta and Sanjay Khanna, while dismissing Yadav's appeal said, "We don't think we can release you on bail."

At the outset, senior advocate Kapil Sibal, appearing for Yadav, said he had been convicted in four cases and had served jail terms of 24 months, 22 months, 20 months and 14 months, respectively.

In most of the cases, several persons who were holding influential positions were acquitted. It was submitted that the Bench said no total Yadav had served 24 years in total in all cases and he cannot split the sentence awarded to him. Sibal said there were no recoveries of any kind from him in the case. He said he was the only major officer under which he was convicted was a conspiracy. The Bench said the high court would look into the merits of the case and at

present it was only hearing the bail appeal. Sibal said, "I am released on bail, I would not run away. My appeal is not being heard in the high court. Currently the ICJ is hearing appeals of 2004 convicts." The apex court Bench said now there are courts meant for expeditious trial of criminal cases against politicians and it can request the Chief Justice of High Court to transfer the cases for trial to the special court. "Let the high court decide the merit of the case in speeds against your conviction and sentence," it said. Sibal contended, "What is the danger if I am released on bail? I have served 24 months in the jail. The Bench said, "By your statement, the 24 months in jail is nothing in comparison to 14 years jail term," and added, "There is no danger except that you are convicted."
