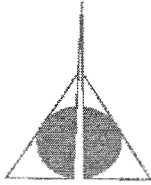


The members of the Company are hereby informed that:
