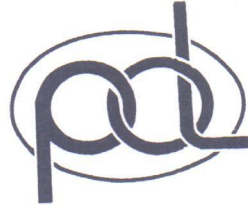

Gist of the Proceedings of the 34th Annual General Meeting of Panchsheel Organics Services Limited held on Friday, September 29, 2023.

The 34th Annual General Meeting ('AGM') of the Members of the Company has been held today i.e. Friday, September 29, 2023 at 4.00 P.M. through Video Conferencing/ Other Audio Visual Means (VC/OAVM) in compliance with the Circulars issued by the Ministry of Corporate Affairs and Securities and Exchange Board of India in this behalf from time to time ("the Circulars).

The Meeting was chaired by Mr. MahendraTurakhia, Managing Director of the Company.

All the members of the Board of Directors, were present at the Meeting. The Statutory Auditors and the Secretarial Auditors of the Company were also present.

The Chairman welcomed all the members attending the AGM. The requisite quorum being present, the Chairman called the meeting to order.

The Chairman gave a brief overview of the performance of the Company during the financial year ended March 31, 2023. The Members were informed that the Company had provided remote e-voting facility to them to cast their votes on all the resolutions set forth in the AGM Notice. Members, who were participating in the meeting and had not cast their votes through e-voting, were provided an opportunity to cast their votes through e-voting at the AGM.

The following Resolutions were moved and approved with the requisite majority.

ORDINARY BUSINESS:-

1. To consider and adopt the audited Financial Statements of the Company for the financial year ended March 31, 2023, together with the Report of the Board of Directors and the Auditors thereon;
2. To declare final dividend on Equity Shares for the financial year ended March 31, 2023.
3. To appoint a Director in place of Mr. RajeshTurakhia (DIN: 00006246), who retires by rotation and, being eligible, offered himself for re-appointment.

It was informed that the results of the remote e-voting and the e-voting facility extended during the meeting hours shall be declared after receipt of the Scrutinizer's Report and the same will be intimated to the stock exchange, NSDL - the service provider and also be uploaded on the website of the Company.

The meeting concluded at 4.30 p.m. (including the time for e-voting facility).
