## आईसीआईसीआई पू. कारोबार करेगी दोगुना

निजी क्षेत्र की बीमा कंपनी आईसीआईसीआई प्रुडेंशियल लाइफ ने कहा है कि वह चालू वित्त वर्ष में अपने नए कारोबार का मूल्य 2,560 करोड़ रुपए यानी दोगुना करने के अपने लक्ष्य को पूरा की दिशा में बढ़ रही है। कंपनी ने 2018-19 में यह लक्ष्य तय किया था जब नए कारोबार का मुल्य (वीएनबी) 1,328 करोड़ रुपए था। लक्ष्य प्राप्ति को लेकर प्रबंधन का भरोसा इस बात से मजबत होता है कि पहली तिमाही में वीएनबी वद्धि अनमान से कहीं अधिक 471 करोड़ रुपए रही है। यह एक साल पहले के 358 करोड़ रुपए की तुलना में 31.7 फीसदी अधिक है। कंपनी के प्रबंधन के अनुसार, पहली तिमाही में अच्छी वृद्धि के चलते अब कंपनी को अपना लक्ष्य पाने के लिए सिर्फ 22.5 फीसदी की वृद्धि हासिल करनी है।

# 5जी से जियो व एयरटेल को होगा फायदा

5जी की जंग में वोडाफोन आइंडिया को दबाकर रिलायंस जियो और एयरटेल की बाजार हिस्सेदारी और राजस्व में होगा इजाफा

नई दिल्ली, 24 जुलाई

गामी 5जी स्पेक्ट्रम नीलामी के लिए करीब 1.75 लाख करोड़ रुपये (90 फीसदी से अधिक) की जंग में वोडाफोन आइडिया (वीआईएल) की कीमत पर रिलायंस जियो और भारती एयरटेल अपनी बाजार हिस्सेदारी और राजस्व को मजबती देने के लिए दमदार स्थिति में हैं। अधिकतर विश्लेषकों ऐसा अनुमान जाहिर

नोमुरा रिसर्च का कहना है कि ऐसा लगता है कि भारत के दूरसंचार क्षेत्र में दो ही कंपनियों का वर्चस्व रहेगा। हालांकि यह समय ही बताएगा कि भारतीय दूरसंचार क्षेत्र द्विध्नुवीय होगा अथवा नहीं। लेकिन आगामी 5जी नीलामी में वोडाफोन आइंडिया की भूमिका काफी सीमित दिखने के आसार हैं। वह संभवतः अपने प्रमुख सर्किल पर ही ध्यान केंद्रित करेगी। उसे अपना 4जी कवरेज बढ़ाने और 5जी में निवेश करने के लिए बहुप्रतीक्षित 20,000 करोड़ रुपये जल्द से जल्द जुटाने की आवश्यकता है।

शुरू में यह स्पष्ट नहीं था कि अदाणी समूह भी 5जी के बहाने मोबाइल टेलीफोनी में दस्तक दे देगा अथवा फिलहाल उसकी भूमिका 5जी स्पेक्ट्रम नीलामी

एंटरप्राइज क्षेत्र तक सीमित रहेगी। युबीएस का कहना है कि वोडाफोन आइडिया के हाई-एंड ग्राहक 5जी सेवाओं के अभाव में अन्य सेवा प्रदाताओं की ओर रुख कर सकते हैं। साल 2020 और 2022 के बीच एयरटेल के पोस्टपेड ग्राहकों की संखया में 30 लाख की बढ़ोतरी हुई। जाहिर तौर पर वोडाफोन आइंडिया से ग्राहकों ने एयरटेल की ओर रुख

वैश्विक रुझानों से पता चलता है कि 5जी सेवाएं लॉन्च होने के 12 से 18 महीनों के दौरान प्रति उपयोगकर्ता औसत राजस्व (एआरपीय)



में 10 फीसदी (चीन) से 20 फीसदी (हॉन्ग कॉन्ग) के दायरे में वृद्धि हुई। भारत में कुछ साल पहले शुरू हुई 4जी सेवाओं के मुकाबले यह बिल्कुल अलग है क्योंकि उस दौरान एआरपीय में उल्लेखनीय गिरावट आई थी। जहां तक 5जी का सवाल है तो इससे जियो और एयरटेल को अधिक राजस्व मिल सकता है।

दूरसंचार कंपनियों के लिए मुख्य परीक्षा 3.5 गीगाहर्ट्ज बैंड (3300-3630) में स्पेक्ट्रम हासिल करने को लेकर होगी। उदाहरण के लिए, 3500-3600 बैंड हासिल करने वाली कंपनी मजबृत स्थिति में होगी, क्योंकि उसका अन्य

दरसंचार कंपनियों के साथ इसे साझा करने को लेकर कोई दखल नहीं होगा। 5जी के लिए आवेदन आमंत्रित करने की प्रक्रिया के तहत यदि 3.5 गीगाहर्ज में कुल स्पेक्ट्रम नीलामी सभी कंपनियों के बीच 300 मेगाहटर्ज तक ररहती है तो इसे 3600 मेगाहर्ट्ज से निर्धारित किया जाएगा और इसकी शुरुआत उस बोलीदाता से होगी, जिसका रैंक यानी स्थान सबसे ऊपर हो। इस रैंक का निर्धारण जटिल प्रक्रिया के तहत किया जाएगा जिसमें यह सब शामिल होगा कि दूरसंचार कंपनी ने कैसे और कितनी बार प्रत्येक राउंड में कीमतें बढाईं।

सबसे ज्यादा बोली लगाने वाली कंपनी को सबसे अच्छा बैंड 3600-3500 मिलेगा। लेकिन दुसरे बोलीदाता (एयरटेल के रूप में) को नैविक सिस्टम से 3400-3500 बैंड में समस्या का सामना करना पड़ेगा, जो 3.4 और 3.425 गीगाहर्ट्ज के बीच 25 मेगाहर्ट्ज का इस्तेमाल कर रहा है।

अंतरिक्ष विभाग ने सिस्टम के पास किसी माइक्रो साइट के लिए 350-1400 किलोमीटर के बफर जोन का संकेत दिया है। एयरटेल ने संबद्ध गणना के आधार पर नियामक को बताया है कि भले ही वह 130-किलोमीटर का बफर बनाए हुए है, लेकिन देश की आबादी के 7 करोड़ लोगों, 600 कस्बों और बफर जोन के 60.000 गांवों को कवर करने में सक्षम नहीं होगी। इसी तरह जहां तक 3300-3400 मेगाहर्ट्ज बैंड का सवाल है, नौसेना देश की समुद्रतटीय लाइन के साथ साथ इसका इस्तेमाल करती है, और साथ ही 100 किलोमीटर का बफर बनाए रखा जाएगा। इस समस्या के समाधान के प्रयास किए जा रहे हैं।

अन्य समस्या यह देखना है कि क्या रिलायंस जियो 700 मेगाहटर्ज बैंड हासिल करती है या नहीं, जो 5जी गुणवत्ता बढ़ाने के लिए जरूरी है। लेकिन यह पिछली दो नीलामियों में बिका नहीं था, क्योंकि इसकी आधार कीमत अधिक थी, जिसमें इस नीलामी में 40 प्रतिशत तक की कमी की गई है। वहीं जियो को इसे खरीदने के लिए नकदी की जरूरत होगी। उसे 10 मेगाहर्ट्ज के लिए अतिरिक्त 39,270 करोड़ रुपये खर्च

लेकिन राय अलग अलग है। एक विश्लेषक का कहना है कि जियो के पास 800 मेगाहटुर्ज बैंड में 10 मेगाहर्ट्ज था, जिसे उसने बड़े पैमाने पर मार्च 2021 की नीलामी में खरीदा था। इसका सिर्फ आधा हिस्सा ही वह 4जी सेवाओं के लिए इस्तेमाल करती है। विश्लेषक ने कहा कि उनकी पिछली चर्चाओं के आधार पर यह पता चला था कि कंपनी 5जी सेवाओं के लिए स्पेक्टम आरक्षित रखेगी।

## वृद्धि को रफ्तार दे रही जेएसडब्ल्यू

इस्पात बनाने वाली देश की सबसे बड़ी कंपनी जेएसडब्ल्यू स्टील ने इस्पात कीमतों में गिरावट और मांग में सुस्ती के मद्देनजर वित्त वर्ष 2023 के लिए अपने पूंजीगत खर्च में कटौती कर रही है लेकिन वह वृद्धि के लिए पूंजीगत खर्च में कोई कटौती नहीं कर रही है।

कंपनी ने वित्त वर्ष 2023 के लिए 20,000 करोड़ रुपये के पुंजीगत खर्च की योजना बनाई थी जिसे घटाकर 15.000 रुपये किया जा रहा है। जेएसडब्ल्य ने वित्त वर्ष 2022 से वित्त वर्ष 2024 के दौरान भारत में अपनी क्षमता को 2.7 करोड़ टन से बढ़ाकर 3.7 करोड़ टन करने के लिए कुल 47,457 करोड़ रुपये के पूंजीगत खर्च की योजना बनाई है। कंपनी इस विस्तार को वित्त वर्ष 2025 में पूरा कर लेगी। जेएसडब्ल्यू स्टील के संयुक्त प्रबंध निदेशक एवं ग्रुप सीएफओ शेषागिरि राव ने कहा कि जब 47.457 करोड़ रुपये के पंजीगत खर्च की घोषणा की गई थी तो वह वृद्धि, स्थिरता और विशेष परियोजनाओं के लिए था।

राव ने कहा, 'पहली तिमाही के प्रदर्शन को देखते हुए हमने सोचा कि हमें इस साल अपने पूंजीगत खर्च कम रखना चाहिए। लेकिन हमने वृद्धि के लिए पूंजीगत खर्च में कोई कटौती नहीं की है।' उन्होंने कहा कि विशेष परियोजनाओं और विवेकाधीन



पूंजीगत खर्च को फिलहाल टाल दिया गया है। जीविका संबंधी पूंजीगत खर्च के एक हिस्से को भी अगले साल के लिए टाल दिया गया है। लेकिन विजयवाडा में 75 लाख टन और भूषण पावर ऐंड स्टील में 25 लाख टन क्षमता विस्तार के लिए वित्त पोषण जारी रहेगा। वित्त वर्ष 2022 में तेजी के बाद वित वर्ष 2023 की पहली तिमाही में जेएसडब्ल्यू स्टील का समेकित शुद्ध लाभ 85.7 फीसदी घटकर 839 करोड़ रुपये रह गया। कंपनी के मुनाफे को वैश्विक इस्पात आपूर्ति एवं लागत में तेजी और इस्पात की मांग एवं मुल्य में गिरावट से झटका लगा। इसके अलावा रुपये में करीब 4 फीसदी की गिरावट के कारण

विदेशी मुद्रा ऋण के बकाये पर मार्क-टु-मार्केट घाटे से भी मुनाफा प्रभावित हुआ। यह प्रभाव करीब 747 करोड़ रुपये का था। इन तमाम कारकों के कारण पहली तिमाही में परिचालन परिदृश्य चुनौतीपूर्ण हो गया। राव ने कहा, 'सरकार ने मई में आयात शुल्क लगा दिया जिससे भारत में धारणा प्रभावित हुई। यह मानकर कि कीमतों में गिरावट आगे भी जारी रही और स्थानीय उपयोगकर्ता उद्योग ने खरीदारी बंद कर दी जिससे खपत में उल्लेखनीय गिरावट आई। निर्यात में भी तिमाही आधार पर 26 फीसदी की गिरावट दर्ज की गई।' भारत में इस्पात की खपत में तिमाही आधार पर 5.6 फीसदी की गिरावट आई।

## सुनील मित्तल का वेतन घटा

दूरसंचार कंपनी भारती एयरटेल के चेयरमैन सुनील मित्तल का वेतन 2021-22 में करीब 5 फीसदी घटकर 15.39 करोड़ रुपये रहा है। कंपनी की वार्षिक रिपोर्ट से यह जानकारी मिली है।

मित्तल का कुल वेतन 2020-21 में 16.19 करोड़ रुपये था। हालांकि 2021-22 में मित्तल का वेतन, भत्ते और प्रदर्शन आधारित प्रोत्साहन 2020-21 के समान ही हैं लेकिन बीते वित्त वर्ष में वेतन में गिरावट की मुख्य वजह अन्य लाभ में गिरावट रही है। दो साल की सालाना रिपोर्ट की तुलना करने पर पता चलता है कि 2021-22 में उन्हें 83 लाख रुपये के भत्ते और अन्य लाभ मिले जो इससे पिछले वित्त वर्ष में 1.62 करोड़ रुपये थे।

और भत्ते करीब 10 करोड़ रुपये रहे थे. जबकि प्रदर्शन आधारित प्रोत्साहन 4.5 करोड़ रुपये था। एयरटेल के प्रवक्ता ने कहा. 'चेयरमैन सुनील भारती मित्तल के कुल पारिश्रमिक में पिछले वर्ष की तुलना में कोई परिवर्तन नहीं आया है। हालांकि 2021-22 आना है।' वहीं भारती एयरटेल के प्रबंध निदेशक गोपाल विट्टल का कुल वेतन 2021-22 में 5.8 फीसदी बढकर 15.25 करोड़ रुपये रहा है।

# 5जी से जियो व एयरटेल को होगा फायदा

## 5जी की जंग में वोडाफोन आइंडिया को दबाकर रिलायंस जियो और एयरटेल की बाजार हिस्सेदारी और राजस्व में होगा इजाफा

नई दिल्ली, 24 जुलाई

गामी 5जी स्पेक्ट्रम नीलामी के लिए करीब 1.75 लाख करोड़ रुपये (90 फीसदी से अधिक) की जंग में वोडाफोन आइडिया (वीआईएल) की कीमत पर रिलायंस जियो और भारती एयरटेल अपनी बाजार हिस्सेदारी और राजस्व को मजबती देने के लिए दमदार स्थिति में हैं। अधिकतर विश्लेषकों ऐसा अनुमान जाहिर

नोमुरा रिसर्च का कहना है कि ऐसा लगता है कि भारत के दूरसंचार क्षेत्र में दो ही कंपनियों का वर्चस्व रहेगा। हालांकि यह समय ही बताएगा कि भारतीय दूरसंचार क्षेत्र द्विध्नवीय होगा अथवा नहीं। लेकिन आगामी 5जी नीलामी में वोडाफोन आइंडिया की भूमिका काफी सीमित दिखने के आसार हैं। वह संभवतः अपने प्रमुख सर्किल पर ही ध्यान केंद्रित करेगी। उसे अपना 4जी कवरेज बढ़ाने और 5जी में निवेश करने के लिए बहुप्रतीक्षित 20,000 करोड़ रुपये जल्द से जल्द जुटाने की आवश्यकता है।

में 10 फीसदी (चीन) से 20 फीसदी (हॉन्ग कॉन्ग) के दायरे में वृद्धि हुई। भारत में कुछ साल पहले शुरू हुई 4जी सेवाओं के मुकाबले यह बिल्कुल अलग है क्योंकि उस दौरान एआरपीय में उल्लेखनीय गिरावट आई थी। जहां तक 5जी का सवाल है तो इससे जियो और एयरटेल को अधिक राजस्व मिल सकता है।

दूरसंचार कंपनियों के लिए मुख्य परीक्षा 3.5 गीगाहर्ट्ज बैंड (3300-3630) में स्पेक्ट्रम हासिल करने को लेकर होगी। उदाहरण के लिए, 3500-3600 बैंड हासिल करने वाली कंपनी मजबृत स्थिति में होगी, क्योंकि उसका अन्य

दरसंचार कंपनियों के साथ इसे साझा करने को लेकर कोई दखल नहीं होगा। 5जी के लिए आवेदन आमंत्रित करने की प्रक्रिया के तहत यदि 3.5 गीगाहर्ज में कुल स्पेक्ट्रम नीलामी सभी कंपनियों के बीच 300 मेगाहर्ज़ तक ररहती है तो इसे 3600 मेगाहर्ट्ज से निर्धारित किया जाएगा और इसकी शुरुआत उस बोलीदाता से होगी. जिसका रैंक यानी स्थान सबसे ऊपर हो। इस रैंक का निर्धारण जटिल प्रक्रिया के तहत किया जाएगा जिसमें यह सब शामिल होगा कि दूरसंचार कंपनी ने कैसे और कितनी बार प्रत्येक राउंड में कीमतें बढाईं।

सबसे ज्यादा बोली लगाने वाली कंपनी को सबसे अच्छा बैंड 3600-3500 मिलेगा। लेकिन दुसरे बोलीदाता (एयरटेल के रूप में) को नैविक सिस्टम से 3400-3500 बैंड में समस्या का सामना करना पड़ेगा, जो 3.4 और 3.425 गीगाहर्ट्ज के बीच 25 मेगाहर्ट्ज का इस्तेमाल कर रहा है।

अन्य समस्या यह देखना है कि क्या रिलायंस जियो 700 मेगाहटर्ज बैंड हासिल करती है या नहीं, जो 5जी गुणवत्ता बढ़ाने के लिए जरूरी है। लेकिन यह पिछली दो नीलामियों में बिका नहीं था, क्योंकि इसकी आधार कीमत अधिक थी, जिसमें इस नीलामी में 40 प्रतिशत तक की कमी की गई है। वहीं जियो को इसे खरीदने के लिए नकदी की जरूरत होगी। उसे 10 मेगाहर्ट्ज के लिए अतिरिक्त 39,270 करोड़ रुपये खर्च

कंपनी ने वित्त वर्ष 2023 के लिए 20,000 करोड़ रुपये के पूंजीगत खर्च की योजना बनाई थी जिसे घटाकर 15.000 रुपये किया जा रहा है। जेएसडब्ल्य ने वित्त वर्ष 2022 से वित्त वर्ष 2024 के दौरान भारत में अपनी क्षमता को 2.7 करोड़ टन से बढ़ाकर 3.7 करोड़ टन करने के लिए कुल 47,457 करोड़ रुपये के पूंजीगत खर्च की योजना बनाई है। कंपनी इस विस्तार को वित्त वर्ष 2025 में पुरा कर लेगी।

जेएसडब्ल्यू स्टील के संयुक्त प्रबंध निदेशक एवं ग्रुप सीएफओ शेषागिरि राव ने कहा कि जब 47,457 करोड़ रुपये के पुंजीगत खर्च की घोषणा की गई थी तो वह वृद्धि. स्थिरता और विशेष परियोजनाओं

राव ने कहा, 'पहली तिमाही के प्रदर्शन को देखते हुए हमने सोचा कि हमें इस साल अपने पंजीगत खर्च कम रखना चाहिए। लेकिन हमने वृद्धि के लिए पूंजीगत खर्च में कोई कटौती नहीं की है।' उन्होंने कहा
