Delhi HC dismisses Omar's plea challenging its office order on final hearing of matters

The Delhi High Court today dismissed former Jammu and Kashmir chief minister Omar Abdullah's plea challenging its circular of April mandating that both parties in a case have to agree for the final hearing to be taken early via conferencing mode.

Omar had contended that his matrimonial appeal against a 2016 trial court order, which dismissed his divorce petition, has been listed for final hearing since February 2017. It was not taken up during the restricted functioning of the courts in view of COVID-19 pandemic as his estranged wife, Payal Abdullah, did not give consent to virtual proceedings. Due to the lack of cooperation by his estranged wife the matter was getting delayed, the former J&K chief minister contended. A bench of Justices Hima Kohli and Subramonium Prasad, however, declined to grant any relief saying lack of cooperation of his estranged wife was not a ground for challenging the high court's April 26 office order. "Simply because the respondent 2 herein (Payal Abdullah) was not consenting to an early hearing, can hardly be a ground to assail the office order. The petition is dismissed as meritless," the bench said

hearing of his appeal in July. The High Court had declined to entertain it saving that its Registrar General has already issued a circular stating that during the restricted functioning of courts due to COVID-19, a request for final hearing of pending matters will be entertained only if both the parties agree.

"In view of the fact that this application is not accompanied by any consent from the other side (Payal) and nor is the counsel for the respondent present in the hearing, though we are informed that an advance copy of the application was served on him, we are not in a position to accede to the prayer made in the application," the high court had said and dismissed the application. On August 30, 2016, the trial court had dismissed Omar's plea seeking divorce from Payal saying he had failed to prove irretrievable breakdown of the marriage. The trial court had said that

Sikh activist, who tried hoisting tricolour on PDP office, detained

JAMMU, NOV 3 /--/ A Sikh activist, who tried to hoist the national flag atop the PDP office here during a protest against remarks by its chief Mehbooba Mufti on the tricolour, was detained by police today, officials

said. October On Amandeep Singh had hoisted the national flag on the boundary wall near the main entrance of the Peoples Democratic Party (PDP) office and a day later, he along with some youths attempted to hoist it on the party's headquarters, but were stopped by police. Senior Superintendent of Police (SSP), Jammu, Sridhar Patil confirmed Singh's detention. He has been detained under some other case and not for disturbance to law and order, the officer said. Police, however, did not give details of the charges against the Sikh activist. Singh has been either booked for violation of COVID-19 protocols and the Disaster Management Act or for trespass, sources said. While the activist was being shifted in a vehicle, he told reporters that he is being "arrested" by police under pressure from the PDP. Led by the station house officer of Gandhinagar, a police team raided Singh's house at Sanjay Nagar and took him in the presence of journalists. Singh's father, who rushed to the Gandhinagar police station following the
