I, Srikant Kumar Puthi, Practicing Company Secretary appointed as Scrutinizer by the Hon'ble National Company Law Tribunal, Hyderabad for the purpose of the scrutinizing the process of remote e-voting and e-voting after 15 minutes of conclusion of the meeting in respect of the item/resolution set forth in the Notice of meetings of Unsecured Creditors of GSS Infotech Limited dated 30.05.2023.

The said appointment as Scrutinizer is under the provisions of Section 108 of the Companies Act, 2013 read with Rules. As the scrutinizer, I have to scrutinize:

- i. The process of e-voting remotely, before the meeting using an electronic voting system on the dates referred to in the Notice calling the meeting of the Unsecured Creditors; and
- ii. The process of e-voting for 15 minutes of the conclusion of the meeting.

The Company had provided remote e-voting facility offered by Central Depository Services (India) Limited (CDSL) to the Unsecured Creditors of the Company.

The cut-off date for determining the eligibility to vote through remote e-voting or be electronic means during Meeting is 29th June 2023.

The remote e-voting was kept open for 3 (three) days from Sunday 02-Jul-2023 09.00 AM (IST) remained open to 5:00 PM (IST) Tuesday 04-Jul-2023.

The Company has also provided remote e-voting facility for 15 minutes after the conclusion of the Meeting, for Unsecured Creditors who have not voted during the above-mentioned period

Management Responsibility

The management of the Company is responsible to ensure the compliance with the requirement of the Companies Act 2013 and rules relating to voting through remote e-voting and voting at the Venue on the resolution contained in the notice of the Meeting of Unsecured Creditors.
