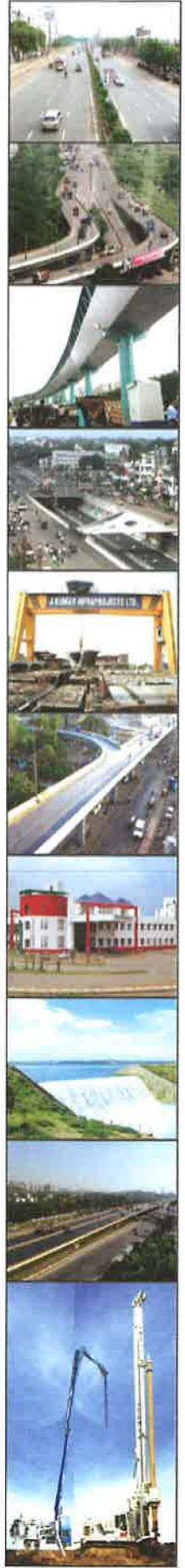
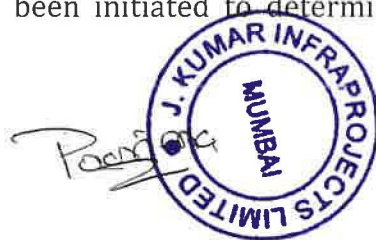

With reference, to the captioned subject, this is to inform you that construction work, was going on in the name of M/s. J. Kumar – J. M. Mhatre (hereinafter referred to as "Joint Venture/ JV"), at Jasai, located in Uran (Raigad district, Navi Mumbai, Maharashtra) for the project named as "Construction of NH-348 (old SH-54) from Km 7.422 to Km 13.160 and Amra Marg from Km 0.000 to Km 5.360 on EPC Mode - Package - 3"

While the Joint Venture, was carrying out the work at the said project, by following all the specifications in accordance with the provisions of the Joint Venture Agreement and standards in accordance with the provisions of the other standard industry practices, on, 2nd November, 2021, around 4:15 P.M., at the said location, and for the said project, a pier cap of the pillar of an under-construction bridge collapsed, causing one fatality and some minor injuries were reported at the site of the Project.

Prima-facia this incident took place, while unloading the concrete from boom placer from one location to another location. In compliance with the Company's protocols, investigation has been initiated to determine the root cause of the accident.

Thereafter the Joint Venture duly informed the Authority of the accident at the said Project, and the Authority thereafter constituted an expert committee to investigate the incident and submit its report of the cause to the said incident.

The report from the expert committee is still awaited. The Company as on 31st March, 2021 has government orders/ tenders of total value of ₹ 1,09,273 million on its books. In this regard, the Company shall be able to successfully complete the works at the project where the incident has occurred and execute all other projects in the pipeline. Further, the Company shall endeavor to extend full cooperation to the authorities/ expert committee and is certain that it shall be able to put behind the unfortunate incident occurred at its project site at the earliest.
