1. Resignation of Mr. S. M. Bhat as the Managing Director

Mr. S. M. Bhat (DIN: 05168265), vide his letter dated 07th September, 2020, has conveyed his decision to resign from the office of / position of the Managing Director / Employee / Director of the Company with immediate effect i.e. from 07th September, 2020.

The Board of Directors accepted his resignation with immediate effect and relieved him from his duties as the Managing Director.

2. Appointment and Re-designation of Mr. Aditya T. Malkani as the Managing Director

Malkani (DIN: 01585637), Non-Executive & Non-Independent Director of the Company, based on the recommendation of the Nomination & Remuneration Committee (NRC), is appointed as the Managing Director of the Company with effect from Monday, 14th September, 2020 for a period of three (3) years i.e. till 13th September, 2023, by the Board of Directors of the Company, subject to the terms & conditions, to be recommended by the Nomination & Remuneration Committee (NRC), and subject to the approval of the shareholders to be taken at the 68th Annual General Meeting (AGM).
