**1. Date, Time and Venue of the Annual General Meeting:**

The 29<sup>th</sup> Annual General Meeting ("AGM") of the Company was held on Friday, September 30, 2022 through Video Conferencing (VC) / Other Audio-Visual Means (OAVM). The Meeting was commenced at 11:00 A.M. (IST) and concluded at 11.44 AM (IST).

**2. Proceedings in Brief:**

- 51 members (including Bodies Corporate through their authorized representative) have attended the meeting via VC/OAVM.
- Ms. Saumya Agrawal, Company Secretary & Compliance Officer of the Company welcomed the Board of Directors and the members of the Company.
- The Following Board of Directors, KMP and key executives were present at the meeting via VC/OAVM:

- The Company Secretary informed that the AGM was held through VC/ OAVM in compliance with the circulars issued by the Ministry of Corporate Affairs, Government of India and Securities and Exchange Board of India.
- Mr. Anurag Gupta, Managing Director of the Company chaired the proceedings of the Meeting.
- The Chairman of Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee were present at the Meeting. The Statutory Auditor was also present at the Meeting.

- The requisite quorum being present, the Chairman called the meeting to order and addressed the members by delivering his speech on the business & performance of the Company and road map ahead. The Chairman also informed that the Commercial Production of subsidiary company has been started in the month of March, 2022.
- The Company Secretary informed that the facility for remote e-voting commenced at 9:00 A.M. on Tuesday, September 27, 2022 and concluded at 5:00 P.M. on Thursday, September 29, 2022. She also informed that voting by electronic means was also available during the AGM and 15 minutes after the conclusion of the AGM to those members who had not already voted by means of remote e-voting. The Company Secretary further informed the members that M/s. BKG & Associates, Chartered Accountant, was appointed as the scrutinizer to scrutinize the voting through electronic means (i.e. remote e-voting and voting at the meeting by using electronic system) in a fair and transparent manner.
- The Company Secretary informed that the Notice of the AGM was already circulated and hence the notice convening this meeting was taken as read. She further informed that the Auditors Report on Standalone and Consolidated Financial Statements and Secretarial Audit Report of the Company for the Financial Year ended March 31, 2022 does not contain any qualifications, reservations and adverse remarks. Hence, the said report was not read out in the meeting as required under the provisions of the Companies Act, 2013.
- Chairman further stated that statutory registers/ records and other applicable documents were available for inspection electronically.
- The following items of business as set out in the Notice convening the 29<sup>th</sup> Annual General Meeting were commenced for the Members consideration and approval:

### Ordinary Business

- i. To receive, consider and adopt the Audited Financial Statements including the Consolidated Financial Statement of the Company for the financial year ended 31<sup>st</sup> March, 2022 and the reports of the Board of Directors and Auditors thereon.
- ii. To appoint Mrs. Navrati Gupta (DIN: 00399022) who retires by rotation and being eligible, has offered herself for re-appointment.
- iii. To appoint M/S BKG & Associates, Chartered Accountants, as Statutory Auditor of the Company

### Special Business

- iv. To consider and re-appoint Mr. Anurag Gupta (DIN: 00398458) as Managing Director of the Company.
- The Company Secretary then opened the 'Questions & Answers' (Q&As) floor for the members who had registered themselves as 'speaker' to ask questions or express their views. The questions raised by the members were duly answered and the members expressed the satisfaction on the performance of the Company.
