

एएआई की इस पहल से लोग काफी आशान्वित हैं। इंडैमर एविएशन के मुख्य कार्याधिकारी राजीव गुप्ता ने कहा, 'यह नीति नए निवेशकों को आकर्षित करेगी और भारत में एमआरओ क्षेत्र को प्रतिस्पर्धी बनाएगी।' एमआरओ एसोसिएशन ऑफ इंडिया के महासचिव पुलक सेन ने कहा, 'प्रस्तावित लाभ को एएआई के हवाई अड्डों पर मौजूदा एमआरओ तक भी पहुंचाना चाहिए और इसे केवल नए एमआरओ तक सीमित नहीं

भारतीय ऋणदाताओं की नजर शापरजी पलोंजी (एसपी) समृह और टाटा समृह के बीच मामले में सर्वोच्च न्यायालय के फैसले पर टिकी हुई है। माना जा रहा है कि शापूरजी पलोंजी के पक्ष में फैसला आने से निर्माण क्षेत्र के लिए वित्त पोषण के नए रास्ते खुलेंगे। कोविड-19 महामारी से प्रभावित कंपनियों के

लिए केवी कामत समिति के सुझावों को ध्यान में रखते हुए एसपी समूह की कई कंपनियों ने दिसंबर की समय-सीमा से पहले ऋण पुनर्गठन के लिए आवेदन किया था। पिछले कुछ महीनों में, समूह की प्रमुख कंपनी शापूरजी पलोंजी ऐंड कंस्ट्रक्शन (एसपीसीपीएल) ने ऋणदाताओं को कोई ऋण भुगतान नहीं किया है, क्योंकि एकमुश्त पुनर्गठन प्रक्रिया पहले ही शुरू हो गई थी। सितंबर में, 530 करोड़ रुपये के मुक्त बैंक बैलेंस में कोष की उपलब्धता के बावजूद यूनियन बैंक ऑफ इंडिया के लिए बकाये का भुगतान नहीं किया गया था।

जहां एसपी समूह के अधिकारियों का कहना है कि सर्वोच्च न्यायालय के फैसले और ऋण पुनर्गठन योजनाओं का आपस में कोई संबंध नहीं हैं, वहीं

ऋणदाताओं का कहना है कि यदि न्यायालय उसे टाटा संस में अपने शेयर गिरवी रखने की अनुमति देता है तो समूह बडी रकम जुटाने में सक्षम होगा। टाटा संस में मिस्त्री परिवार की 18.5 प्रतिशत हिस्सेदारी है, जबिक शेष पर टाटा ट्रस्ट्स और टाटा समूह कंपनियों का स्वामित्व है।

सुनवाई के दौरान, जहां टाटा समूह ने मिस्त्री परिवार की हिस्सेदारी की वैल्यू 80,000 करोड़ रुपये पर अनुमानित की, वहीं मिस्त्री समूह शेयर कीमतों में ताजा तेजी को ध्यान में रखते हुए 1 लाख करोड़ रुपये ज्यादा की उम्मीद कर रहा है।

पिछले साल अप्रैल में, वित्तीय दिग्गज केकेआर ने शापरजी पलोंजी इन्फ्रास्टक्चर कैपिटल की पांच चाल सौर ऊर्जा परिसंपत्तियां 1.554 करोड रुपये में खरीदी थीं। समूह ने इस रकम का इस्तेमाल अपने निर्माण व्यवसाय में कर्ज घटाने के लिए किया। लेकिन यह रकम अन्य जरूरतों को परा करने के लिए पर्याप्त नहीं थी, क्योंकि देशव्यापी लॉकडाउन के बाद पुरा निर्माण व्यवसाय ठप हो गया था और बिक्री गिरंकर सबसे निचले स्तर पर आ गई थी। बाद में समूह ने टाटा संस में अपनी हिस्सेदारी गिरवी रखने की कोशिश की, लेकिन टाटा समुह अदालत चला गया और कोष उगाही सौदे पर रोक

एलऐंडटी के पूर्णकालिक निदेशक एवं वरिष्ठ कार्यकारी उपाध्यक्ष (यूटिलिटीज) टी माधवदास के हवाले से विज्ञप्ति में कहा गया है, 'बांग्लादेश का लक्ष्य इस वर्ष सार्वभौमिक बिजली का उपयोग करना है। बिजली हस्तांतरण क्षमता को बेहतर करने से देश की ग्रिड की विश्वसनीयता और दक्षता में सुधार होगा और इसकी पुंजी एवं आर्थिक विकास केंद्रों के लिए एकीकृत विकास की सुविधा होगी। ये परियोजनाएं सीमा पार से बिजली के व्यापार को भी गति प्रदान करेंगी।'

अन्य सलाहकार फर्मों के विशेषज्ञों ने भी इससे सहमति जताई है। सलाहकार फर्म कार्नी के पार्टनर राहुल मिश्रा ने कहा, 'स्टीकर कीमतों पर इलेक्ट्रिक कार सस्ती हो सकती है लेकिन उसकी उपलब्धता लगातार चुनौतीपूर्ण रहेगी। जो लोग इलेक्ट्रिक कार खरीद सकते हैं उनके लिए हम इसे दूसरी या तीसरी कार के रूप में देख सकते हैं।'

केंद्र और राज्य सरकारों ने इलेक्ट्रिक मोबिलिटी को रफ्तार देने के लिए पिछले छह वर्षों के दौरान विभिन्न उपाय किए हैं। केंद्र सरकार की फास्टर एडॉप्शन ऐंड मैन्युफैक्चरिंग ऑफ हाइब्रिड ऐंड इलेक्ट्रिक व्हीकल्स (फेम 2) योजना इसका एक उदाहरण है।

केपीएमजी की एक रिपोर्ट में कहा गया है कि निवेश को प्रोत्साहित करने के लिए राज्य सरकार के प्रोत्साहन से मूल्य शृंखला में आपूर्ति पक्ष की समस्याएं दूर हो सकती हैं, लेकिन यह पर्याप्त नहीं हो होगा। रिपोर्ट में कहा गया है कि राज्यों को आईसीई वाहनों के साथ अंतर को कम करने के लिए मांग को प्रोत्साहित करने पर ध्यान देने की

विभिन्न प्रकार के प्रोत्साहन को व्यक्तिगत उपयोग के लिए सस्ते एवं आकर्षक ईवी मॉडल में बदलना अभी बाकी है। अब तक केवल तीन विनिर्माता हैं जो 300 किमी से अधिक रेंज वाले मॉडल बनाते हैं। सबसे सस्ती और सबसे ज्यादा बिकने वाली इलेक्टिक वाहन फिलहाल टाटा नेक्सन ईवी है जिसकी कीमत 14 से 16 लाख रुपये के बीच है।

हुंडई की कोना इलेक्ट्रिक कार की कीमत 24 लाख रुपये से शुरू होती है और बाजार में इसकी प्रमुख प्रतिस्पर्धी एमजी जेडएस ईवी है जिसकी कीमत 21 लाख रुपये से शुरू होती है। नेक्सन ईवी एकमात्र ऐसा मॉडल है जो खरीदारों के एक बड़े हिस्से को अपनी ओर आकर्षित करने करने में कामयाब रहा है।

मारुति अभी होड़ से दूर

यात्री कार बाजार की अग्रणी कंपनी मारुति सुजुकी अभी इलेक्ट्रिक वाहन श्रेणी से काफी दूर है। मारुति सुजूकी के चेयरमैन आरसी भार्गव का कहना है कि निकट भविष्य के लिए भी कंपनी की ऐसी कोई योजना नहीं है।

भार्गव ने कहा, 'आप ऐसा क्यों सोचते हैं जो पिछले साल नहीं हुआ वह इस साल हो जाएगा? कुछ भी नहीं बदला है। कोई भी भारत में बैटरी नहीं बना रहा है या बैटरी बनाने वाले संयंत्र में निवेश भी नहीं कर रहा है।' उन्होंने कहा कि इलेक्ट्रिक वाहन श्रेणी में लोगों के न उतरने का मुख्य कारण अधिक लागत और बुनियादी ढांचे का अभाव है। भार्गव ने कहा, 'डेढ़ साल पहले लोगों ने दावा किया था कि लीथियम बैटरी की लागत में भारी कमी आएगी।'
