**Sub: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 - Allotment of Equity Shares of the Bank pursuant to exercise of Stock Options under Employee Stock Option Scheme 2016 ("ESOP Scheme 2016") and Suryoday ESOP Scheme 2019 ("ESOP Scheme 2019")**

This is to inform that **37,399** Equity Shares of face value of Rs. 10/- each have been allotted today, November 06, 2024, pursuant to the exercise of Options granted to the employees of the Bank under the ESOP Scheme 2016 and ESOP Scheme 2019. Of **37,399** Equity Shares, 700 Equity Shares have been allotted under the ESOP Scheme 2016 at the Exercise Price of Rs. 140.00 per Equity Share and 36,699 Equity Shares have been allotted under the ESOP Scheme 2019 (*i.e. 35,551 Equity Shares at the Exercise Price of Rs. 114.25 per Equity Share and 1,148 Equity Shares at the Exercise Price of Rs. 136.75 per Equity Share*). The Equity Shares allotted are fully paid-up and shall rank pari passu with the existing Equity Shares of the Bank in all respects. The Bank will be submitting the application for listing of the aforesaid 37,399 Equity Shares to National Stock Exchange of India Limited and BSE Limited, in due course.

We further inform that, post allotment of abovementioned Equity shares, the paid-up Equity Share capital of the Bank has increased from Rs. 1,06,24,74,250/- comprising of 10,62,47,425 Equity Shares of Rs. 10/- each fully paid-up to Rs. 1,06,28,48,240/- comprising of 10,62,84,824 Equity Shares of Rs. 10/- each fully paid-up.

In terms of Regulation 10(c) of the SEBI (Share Based Employee Benefits and Sweat Equity) Regulations, 2021 ("**SEBI SBEB Regulations**"), the details of shares allotted as above are given in the **Annexure** to this intimation.
