posed of a petition seeking suo motu proceedings against Trinamool Congress (TMC) general secretary and MP Abhishek Banerjee for his comments against the judiciary. Kaustav Bagchi, a HClawyer, moved the di-

vision bench of Justices Sabyasachi Bhattacharya and Ajoy Kumar Mukherjee against Banerjee, saying his comments were tantamount to contempt of court and therefore judicial proceedings should be initiated

The bench observed that there was no need

for suo motu judicial proceedings on the matter as it would be difficult to go ahead with a "functioning judicial system" if the courts start taking cognisance of every comment.

The country's judicial system is not so fragile that such comments could hamper its sanctity and hence the comments should be ignored, it added. The bench, however, said that people holding public offices should refrain from making comments that could do harm to the prestige of the judiciary.

यह आम बात हो गई है कि चिकित्सा के लिए डॉक्टर पर भरोसा करना होता है लेकिन डॉक्टर परभरोसा करनेकी बजाय उसे प्रताड़ित करना, मरीज की हालत बिगड़ने अथवा मौत हो जाने की स्थिति में मारपीट व तोडफोड़ के अलावा सीधे मुकदमा दज्र करवा दिया जाता है। नतीजन मरीजों काउपचार करने की बजाय डॉक्टरों को पुलिस व कोर्ट के चक्कर लगाने पड़ते है केस में दल हो न हो परन्तु मुकदमा र्द होते ही पुलिस की कार्यवाही आरंभ हो जाता है ऐसे हालात में डॉक्टरों के लिए मरीजों की सेवा करना कठिन ही नहीं असंभव होने लगा है क्योंकि डॉक्टर की पूरी कोशिश होती है कि मरीज का जितना जल्द ही उपचार किया जाय दवा के साथ वह प्रार्थना भी करता है कि उसका मरीज शीघ्र स्वज्ञथ हो, अपवाद स्वरूप ही ऐसा होता है कि उपचार के दौरान मरीज की हालत बिगड़ जाती है या मोत हो जाती है। मौत के कई कारण हो सकते है। जरूरी नहीं कि डॉक्टर के इलाज की वजह सेही मौत हुई हो लेकिन परिजन आंदोलित हो जाते है और सारा गुस्सा डॉक्टर या चिकित्साकर्मियों पर भी निकालने में देर नहीं करते तो क्या डॉक्टर उपचार करना छोड़ दे। डॉक्टर को थोड़ी भी आशंका हो तो वह खतरा मोल लेने की बजाय मरीज को रेफ कर देता है ताकि बिगड़ती हालत के लिए उसे जिम्मेदार नहीं ठहराया जा सके या हालत पहले से ही बिगड़ी हो और ठीकरा उसके सिर न फूट जाय। थाने में जाने की बजाय आनलाइन भी मुकदमा दर्ज करा कर परिजन संकट पैदा कर देते है।
