Subject: Information/application submitted to PNRB under Regulation 17/18 for Noida, Faridabad & Gurugram Geographical Areas (GAs)

Sir,

This has reference to the Information/application submitted to PNRB under Regulation 17/18 for Gurugram, Faridabad & Noida Geographical Areas (GAs) vide various submissions to PNRB. Several issues and disputes have been raised by the competing entities for aforesaid GAs, the key issue involved is the authorization of aforesaid GAs for CGD operations. Since different aspect involved on regulatory and legal sides demand its early resolution with an objective of expansion of CNG, PNG and gas supply to industrial and commercial consumers. Keeping this in background and the order from Hon'ble Supreme court, it has been decided by the Board to first address the authorization issue based on the submission made by the entities, various orders passed by various superior courts and other relevant factors.

In this regard, PNGRB have examined the submissions in terms of the provisions of PNGRB Act 2006 and the notified Regulations thereunder and followings have been observed:

1. Noida GA:

- (i) IGL submissions vide letter dated 06.10.2008 and additional submissions dated 23.12.2022 have been examined. It has been observed that IGL was nominated as implementing agency for development of CGD network in Noida by central Government vide letter dated 08.04.2004. Further, IGL had started laying, building, operating, or expanding CGD network in Noida before the appointed day. Accordingly, submitted information under Regulation 17 read with Section 17 (2) of the PNGRB Act, the IGL is qualifying for acceptance of authorization for Noida GA. Based on the same, Board has decided to issue acceptance of authorization to IGL for Noida districts (Including Greater Noida). Acceptance of authorization is enclosed as Annexure-A.
- (ii) ATGL's submission dated 25.06.2008 and additional submissions dated 02.12.2012, 09.12.2022, 16.01.2023, 02.02.2023, 17.02.2023, 21.02.2023, 24.02.2023 & 21.03.2023 have been examined. ATGL is meeting the requirements of Regulation 18 (2) (a) to 18 (j), except 18 (2) (e) & (i) and accordingly, their application does not qualify for authorization under Regulation 18 of CGD authorization Regulation. Since reasonable opportunity has already been exercised by ATGL through its various submissions as mentioned above, accordingly, the application of ATGL under Regulation 18 for Noida GA cannot be consider for authorization. A speaking Order for the same shall be issued by the Board separately.

2. Faridabad GA

- i. From examination of the information submitted by IGL on 06.10.2008 and their subsequent additional submissions on 23.12.2022, it is observed that IGL only partially fulfills the requirements given under the proviso of Section 17 (2) of the PNGRB Act (as IGL was nominated as implementing agency by Central Government, but did not start any laying, building or operating CGD network before the appointed day) and accordingly, their information under Regulation 17 read with Section 17 (2) of the PNGRB Act does not qualify for acceptance of authorization of Faridabad GA.

- ii. ATGL did not meet the requirement of Regulation 18(2) (e) of CGD Authorization Regulations. However, ATGL meets the requirement of Regulation 18(2)(a) to 18 (2) (d) and 18(2) (g) to (i) of CGD Authorization Regulations.
- iii. Both the entities are not found fully qualified for authorization for Faridabad GA however, ATGL has done significant work in Faridabad GA for expansion of the CGD network. As per the data submitted by ATGL at PNGRB's e-portal, as on 31.12.2022, ATGL has achieved 91,625 PNG, 29 CNG Stations and 4431 inch km of steel and MDPE pipeline. Considering the present situation of ATGL and considering the communication of MoPNG vide letter dated 08.04.2004 to IGL, Board has decided to issue authorization to IGL and ATGL for Faridabad district (Faridabad -1 and Faridabad-2 respectively) under Section 16 of PNGRB Act. The details of authorization given as Annexure-B & C.
- iv. In case of some operating existing infrastructure of ATGL in Faridabad-1, as on date of issuance of authorization of respective GAs, the ATGL shall be allowed to operate their existing infrastructure.

3. Gurugram GA:

- (i) From examination of the information/ submitted by IGL on 06.10.2008 and their subsequent additional submissions on 23.12.2022, it is observed that IGL only partially fulfills the requirements given under the proviso of Section 17 (2) of the PNGRB Act (as IGL was nominated as implementing agency by Central Government but did not start any laying, building or operating CGD network before the appointed day) and accordingly, their information under Regulation 17 read with Section 17 (2) of the PNGRB Act is not qualified for acceptance of authorization of Gurugram GA.
- (ii) It is noted that IGL though does not qualify as per the provisions mentioned above, as on date, IGL has laid significant infrastructure in Gurugram. The creation of these infrastructure was undertaken by IGL after their clearance from Director of Industries, Haryana Government in the year 2017. Considering the significant work done and communication issued by MoPNG vide letter dated 08.04.2004 to IGL for Gurugram GA, the Board decided to issue authorization to IGL for the part area of Gurugram District (Gurugram -1) under Section 16 of the PNGRB Act. The details of authorization given as Annexure-D
- (iii) As per evaluation of the submissions dated 08.09.2008, 16.11.2022; 13.02.2023 and 14.03.2023 from HCGDL, the entity is found fully qualified under the

provisions of regulation 18 of the CGD Authorization Regulations for Gurugram GA. Accordingly, the application submitted by the HCGDL is accepted by the Board and part of the Gurugram District (Gurugram -2) is authorized to HCGDL. The details of authorization given as Annexure-E

(iv) In case of some existing operating infrastructure of IGL in Gurugram-2 or existing operating infrastructure of HCGDL in Gurugram -1, as on date of issuance of authorization of respective GAs, the respective entities shall be allowed to operate their existing infrastructure.

Sir,

This is with reference to the above-mentioned communications on the subject. PNGRB is pleased to issue acceptance of Central Government authorization to **Indraprastha Gas Limited (IGL) for Noida (including Greater Noida) CGD Network** (in Gautam Buddh Nagar district) subject to the following terms and conditions:

- i. The issuance of this letter is subject to submission of Performance Bank Guarantee of amount Rs.25 crore as per the requisite format. The PBG is a guarantee for timely commissioning of the project as per the prescribed targets in the MWP and for meeting the service obligations during the operating phase of the project. The Performance Bank Guarantee submitted shall remain in full force during the project period and shall have to be renewed in a block of three years.
- ii. IGL shall abide by the provisions of the PNGRB Act, 2006 and relevant regulations including amendments thereof and regulations, if any, framed from time to time.
- iii. IGL shall abide by the Technical Standards and specifications including Safety Standards (T4S) for, City and/or Local Natural Gas Distribution Networks Regulations 2008 including the Emergency Response & Disaster Management Plan (ERDMP).
- iv. IGL shall abide to Quality of Service standards as per regulations framed under PNGRB Act, 2006.

- v. The Authorized Area for laying, building, operating or expanding the **Noida (including Greater Noida)** CGD Network shall cover an area as depicted in the indicative and not to scale drawing or map, enclosed herewith.
- vi. IGL is allowed an exclusivity period under the Petroleum and Natural Gas Regulatory Board (Exclusivity for City or Local Natural Gas Distribution Networks) Regulations, 2008, in respect of the following, namely:
- a) The exclusivity for laying building or expansion of the CGD Network shall be 25 years from the date of issue of acceptance of Central Government authorization.
- and,
- b) The exclusivity from the purview of common carrier or contract carrier shall be for a period of 5 years from the date of issue of acceptance of Central Government authorization.
- vii. The Project milestones during the period of exclusivity from the purview of common carrier or contract carrier shall be as given in **(Annexure-1)** enclosed.
2. Violation of any condition/conditions mentioned in clause I shall be treated as default and shall be dealt with as per the provisions of the PNGRB Act, 2006.
3. The tariff applicability will be as per Section 22 of the PNGRB Act, 2006 and the Judgment of Hon'ble Supreme Court of India in the SLP No. 22273 of 2012 i.e. Civil Appeal No. 4910 of 2015.

This is with reference to the information submitted by you vide communications referred above for acceptance of Central Government authorization for development of City Gas Distribution Network in the Geographical Area of **Faridabad district**.

2. From examination of the information/ submitted by IGL on 06.10.2008 and subsequent additional submissions on 23.12.2022, it is observed that IGL only partially fulfil the requirements given under the proviso of Section 17 (2) of the PNRB Act (as IGL was nominated as implementing agency by central Government but did not started any laying, building or operating CGD network before appointed day) and accordingly, your information under Regulation 17 read with Section 17 (2) of the PNRB Act is not qualified for acceptance of authorization of Gurugram GA

3. However, the Petroleum and Natural Gas Regulatory Board has decided to grant you the authorization to Lay, Build, Operate or Expand City or Local Natural Gas Distribution Network in **Faridabad-1 GA** (in Faridabad district) under Section 16 of the PNRB Act, 2006, subject to submission of a Performance Bank Guarantee (PBG) for an amount of Rs. 3 crore (Rupees Three crore) as per the requisite format. The PBG is a guarantee for timely commissioning of the project as per the prescribed targets in the MWP and for meeting the service obligations during the operating phase of the project.

3. Further, on the basis of the submissions made, the following terms and conditions have been finalised by the Petroleum and Natural Gas Regulatory Board which shall be applicable

during the construction as well as operative phase of the said City or Local Natural Gas Distribution Networks systems:

- i. The Authorized Area for laying, building, operating or expanding the **Faridabad-1** CGD Network shall cover an area depicted as **Faridabad-1** in the indicative and not to scale drawing or map, enclosed herewith.
- ii. The activities of laying, building, operating or expansion of the CGD Network to commence within a period of 180 days from the date of this authorization.
- iii. The activities permitted above shall have to be completed as per the approved time schedule enclosed at **Annexure 1**. Any failure on the part of the entity in complying with the milestones prescribed in the time schedule shall lead to consequences as specified under regulation 16 of the Petroleum and Natural Gas Regulatory Board (Authorizing Entities to Lay, Build, Operate or Expand City or Local Natural Gas Distribution Networks) Regulations, 2008.
- iv. The entity shall design and install an optimal size of the infrastructure in terms of pipelines of various types including steel belting of the authorized area, online compressors of adequate capacity for compressing of natural gas into CNG, allied equipment and facilities in the CGD network as identified in its DFR, depending upon the potential demand for natural gas. The infrastructure in the CGD network should be adequate to maintain uninterrupted flow of natural gas in the pipelines and be also able to maintain supplies at adequate pressure to online CNG stations.
- v. The entity shall maintain an uninterrupted supply of natural gas to all categories of customers in the CGD network. In the event of any disruption in the supply of natural gas in the CGD Network, first priority shall be accorded to restoration of supplies to domestic PNG customers. In case of disruption of supply to domestic PNG customers for more than twelve hours, the entity shall compensate to the domestic customer on the following basis: -
 - a) the normative volume of natural gas consumption for the first domestic PNG connection for cooking requirements based on last three months weighted average consumption per day to be applied for each day's disruption and multiplied by ten;
 - b) normative value of natural gas consumption shall be based on last three months' weighted average billing price of natural gas for supplies to the first domestic PNG connection for cooking requirements; and
 - c) the value of compensation shall be equal to normative volume of natural gas consumption as per clause (a) multiplied by normative value as per clause (b) and shall be adjusted by allowing a credit to the domestic PNG Customer in the

next billing cycle or in the next pre-paid smart card in case of smart card metering.

- d) In case the disruption of supplies is attributed to any fault of the domestic PNG customer, no compensation shall be payable by the entity.
- vi. The entity is allowed an exclusivity period under the Petroleum and Natural Gas Regulatory Board (Exclusivity for City or Local Natural Gas Distribution Networks) Regulations, 2008, in respect of the following:
- a) 300 months from the date of issue of this communication for laying, building and expansion of the CGD network; and
- b) 60 months from the date of issue of this communication in terms of an exemption from the purview of common carrier or contract carrier for the CGD network:

Provided that the entity meets the obligations in line with the Petroleum and Natural Gas Regulatory Board (Exclusivity for City or Local Natural Gas Distribution Networks) Regulations, 2008:

Provided further that the period of exclusivity allowed under sub-clause (a) or sub-clause (b) may be terminated before the expiry of the period mentioned above in line with the provisions under Petroleum and Natural Gas Regulatory Board (Exclusivity for City or Local Natural Gas Distribution Networks) Regulations, 2008.

- vii. The authorized entity shall be required to take prior approval from the Board for creation of any lien, charge or hypothecation of the CGD network to secure finances for the project and furnish details of utilization of funds. However, in case of raising funds from any financial institution or bank, the entity will be required to only inform the Board of the sanction of the funds within a period of seven days.
- viii. The entity shall submit a detailed and clear financial closure report to the Board within a period of two hundred and seventy days from the date of authorization issued by the Board.
- ix. The entity shall publish on its website the network tariff for transportation of natural gas as well as the compression charge for CNG in the CGD network in the authorized area which is also annexed to this schedule.
- x. The entity shall publish the applicable retail selling price of PNG for all categories of customers and also for the purpose of invoicing in Rs./ MMBTU.
- xi. The entity shall publish and display the retail selling price of CNG for the purpose of invoicing to CNG customers in Rs./Kg at all CNG dispensing stations.

With reference to your application for laying, building, operating or expanding the City Gas Distribution (CGD) network in Gurugram district in the State of Haryana, it has been decided to grant you the authorisation subject to the Petroleum and Natural Gas Regulatory Board (Authorising Entities to Lay, Build, Operate or Expand City or Local Natural Gas Distribution Networks) Regulations, 2008 for **Gurugram-2 GA**, upon the following terms and conditions, namely:-

1. The Authorized Area for laying, building, operating or expanding the Gurugram-2 CGD Network shall cover an area depicted as Gurugram-2 in the indicative and not to scale drawing or map, enclosed herewith.
2. The activities permitted above shall have to be completed as per the approved time schedule enclosed at **Annexure 1**. Any failure on the part of the entity in complying with the milestones prescribed in the time schedule shall lead to consequences as specified under regulation 16 of the Petroleum and Natural Gas Regulatory Board (Authorizing Entities to Lay, Build, Operate or Expand City or Local Natural Gas Distribution Networks) Regulations, 2008.
3. The entity shall design and install an optimal size of the infrastructure in terms of pipelines of various types including steel belting of the authorized area, online compressors of adequate capacity for compressing of natural gas into CNG, allied equipment and facilities in the CGD network as identified in its DFR, depending upon the potential demand for natural gas. The infrastructure in the CGD network should be

adequate to maintain uninterrupted flow of natural gas in the pipelines and be also able to maintain supplies at adequate pressure to online CNG stations.

4. The entity shall maintain an uninterrupted supply of natural gas to all categories of customers in the CGD network. In the event of any disruption in the supply of natural gas in the CGD Network, first priority shall be accorded to restoration of supplies to domestic PNG customers. In case of disruption of supply to domestic PNG customers for more than twelve hours, the entity shall compensate to the domestic customer on the following basis: -
- a) the normative volume of natural gas consumption for the first domestic PNG connection for cooking requirements based on last three months weighted average consumption per day to be applied for each day's disruption and multiplied by ten;
 - b) normative value of natural gas consumption shall be based on last three months' weighted average billing price of natural gas for supplies to the first domestic PNG connection for cooking requirements; and
 - c) the value of compensation shall be equal to normative volume of natural gas consumption as per clause (a) multiplied by normative value as per clause (b) and shall be adjusted by allowing a credit to the domestic PNG Customer in the next billing cycle or in the next pre-paid smart card in case of smart card metering.
 - d) In case the disruption of supplies is attributed to any fault of the domestic PNG customer, no compensation shall be payable by the entity.
5. The entity is allowed an exclusivity period under the Petroleum and Natural Gas Regulatory Board (Exclusivity for City or Local Natural Gas Distribution Networks) Regulations, 2008, in respect of the following:
- a) 300 months from the date of issue of this communication for laying, building and expansion of the CGD network; and
 - b) 60 months from the date of issue of this communication in terms of an exemption from the purview of common carrier or contract carrier for the CGD network:

Provided that the entity meets the obligations in line with the Petroleum and Natural Gas Regulatory Board (Exclusivity for City or Local Natural Gas Distribution Networks) Regulations, 2008:

Provided further that the period of exclusivity allowed under sub-clause (a) or sub-clause (b) may be terminated before the expiry of the period mentioned above in line

8. The entity shall publish the applicable retail selling price of PNG for all categories of customers and also for the purpose of invoicing in Rs./ MMBTU.
9. The entity shall publish and display the retail selling price of CNG for the purpose of invoicing to CNG customers in Rs./Kg at all CNG dispensing stations.
10. The entity shall submit a detailed and clear financial closure report to the Board within a period of two hundred and seventy days from the date of authorisation issued by the Board under regulation 10.
11. The entity shall abide by-
 - (a) the service obligations as specified under regulation 14 of the Petroleum and Natural Gas Regulatory Board (Authorizing Entities to Lay, Build, Operate or Expand City or Local Natural Gas Distribution Networks) Regulations, 2008;
 - (b) the service obligations specified under the Petroleum and Natural Gas Regulatory Board (Exclusivity for City or Local Natural Gas Distribution Networks) Regulations, 2008;

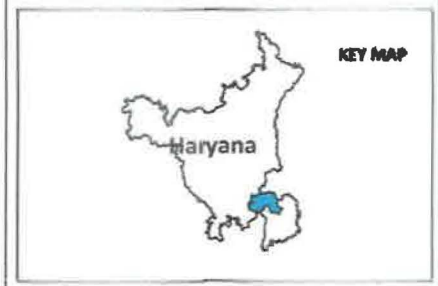
