In the meeting of the Board of Directors of Simbhaoli Sugars Limited, held on today i.e., Saturday, June 27, 2020, which commenced at 4.00 PM and concluded at 6:15 PM, the decisions were taken as follows:

The consolidated audited financial results for the year ended on March 31, 2020 could not be considered and approved due to non-finalization of audited financial results of Simbhaoli Power Private Limited (SPPL), a material subsidiary company, and the Company will re-convene the meetings of the Audit Committee and Board of Directors to consider and approve the standalone and consolidated audited financial results for the year ended March 31, 2020 within the permissible time as prescribed under the provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Accordingly, the Trading Window for dealing in securities of the Company shall remain closed till 48 hours after the declaration of financial results for the quarter ended June 30, 2020 as per the Code of Conduct to regulate, monitor and report trading by Designated Persons of the Company under the Securities and Exchange Board of India (Prohibition of Insider Trading) Regulations, 2015, as amended. This is being notified to all Designated Persons, their immediate relatives through them and other insiders under the above Regulations.
