कधी कांदा, टोमॅटो, तर कधी कोथिंबीर या पिकातून लाखो रुपये शेतकऱ्यांना मिळाल्याची आनंदवार्ता क्वचित ऐकायला मिळतात; मात्र शेती उत्पादन घेताना आर्थिक फटका अनेकदा होत असतो. गेल्या काही दिवसांपूर्वी तेजीत असलेली कोथिंबीरची जुडी लासलगाव बाजार समितीत अवघ्या ५१ पैशाला पुकारल्याने शेतकऱ्याने या जुड्या विकण्यापेक्षा फेकून देण्यात समाधान मानले.

मध्यंतरी कोथिंबिरीला चांगले भाव मिळाल्याची आनंदवार्ता ऐकून आपल्यालाही यंदा चांगले पैसे होतील या हेतूने चांदवड तालुक्यातील वाहेगाव साळ येथील शेतकरी ज्ञानेश्वर आहेर यांनी कोथिंबीरची लागवड केली; मात्र कमी पावसाचा परिणाम म्हणून उशिराने कोथिंबीर शेतात तयार झाली.

धरणात ८०.९७ टीएमसी पाणीसाठा

कराड: पाटण तालुक्यातील कोयना धरणांतर्गत येणाऱ्या सर्वच विभागात पावसाचा वेग मंदावला असून, त्यामुळे धरणांतर्गत विभागातून येणाऱ्या पाण्याचे प्रमाणही घटले आहे. धरणात आता एकूण पाणीसाठा ८०.९७ टीएमसी तर उपयुक्त साठा ७५.९७ टीएमसी झाला आहे. पावसाचे प्रमाण जरी घातले असले तरी पावसाळी हंगामातील ऑगस्ट व सप्टेंबर या दोन्ही महिन्यांत पावसाचे प्रमाण वाढून उर्वरित पाणीसाठा होणे सहजशक्य असल्याचा विश्वास धारण व्यवस्थापनाने व्यक्त केला आहे.

कोयना धरणांतर्गातील विविध विभागात हलक्या स्वरूपाचा पाऊस पडत असल्याने धरणात सरासरी १२,४४७ क्युसेक्स पाण्याची आवक होत असून, हे धरण पूर्ण क्षमतेने भरण्यासाठी यापुढे २४.२८ टीएमसी पाण्याची आवश्यकता आहे. मात्र पावसाचे दिवस

अद्यापही बाकी असल्याने उर्वरित धारण भरणं सहज शक्य आहे,त्यामुळेच धरण पायथा वीजगृहातील दोन जनित्राद्वारे ४० मेगॅवॅट वीजनिर्मिती करून २१०० क्युसेक्स पाणी पूर्वेकडे कोयना नदीपात्रात सोडण्यात येत आहे.धरणांतर्गत विभागासह पाटण तालुक्यातही पावसाचा जोर कमी आहे.धरणांतर्गत विभागातून सरासरी १२,४४७ क्युसेक्स पाण्याची आवक होत असल्याने धरणातील पाणीसाठ्यात संथगतीने वाढ सुरू आहे धरणात आता एकूण पाणीसाठा ८०.९७ टीएमसी तर उपयुक्त पाणीसाठा ७५.९७ टीएमसी इतका झाला आहे . गेल्या चोवीस तासात धरणातील पाणीसाठ्यात केवळ ०.८९ टीएमसी तर पाणीपातळीत एक फूट वाढ झाली आहे.

शुक्रवार संध्याकाळी पाच ते शनिवारी संध्याकाळी पाच या चोवीस तासांत व एक जूनपासूनचा एकूण पाऊस कंसात पुढीलप्रमाणे कोयना २२ (३०८९) मिलिमीटर, नवजा ३० (४४०१) मिलिमीटर व महाबळेश्वर ३१ (४०६२) मिलिमीटर पावसाची नोंद झाली आहे.

उपमुख्यमंत्र्यांची घोषणा ; प्रवीण दरेकरांच्या मागणीला यश

मुंबई : कोकणात दरवर्षी पावसाळ्यात दरडी कोसळतात. गेल्या महिन्यात रायगड जिल्ह्यातील इर्शाळवाडी येथे दरड कोसळून २९ जणांचा दुर्दैवी मृत्यू झाला होता. या पार्श्वभूमीवर भाजप गटनेते आमदार प्रवीण दरेकर यांनी विधान परिषदेत कोकणात ३ ते ४ ठिकाणी कायमस्वरूपी आपत्ती निवारण केंद्रे उभारावी, अशी मागणी केली होती. दरेकर यांच्या मागणीला यश आले असून, उपमुख्यमंत्री देवेंद्र फडणवीस यांनी कोकणात कायमस्वरूपी आपत्ती निवारण केंद्रे उभारणार, अशी घोषणा केली आहे.

शुक्रवारी विधान परिषदेत आ. दरेकर यांनी उपमुख्यमंत्री फडणवीस यांचे काही मुद्दे उपस्थित करून लक्ष वेधले. दरेकर म्हणाले की, मुंबईत गृहनिर्माण संस्थांची मोठी परिषद झाली. त्यात १५ अत्यंत क्रांतिकारी निर्णय गृहनिर्माण संस्थांसाठी, सभासदांसाठी घेण्यात आले. त्याचे डिम्ड कन्व्हेन्स, हस्तांतरण फी असे जीआरही निघाले. अजून १३ जीआर प्रलंबित आहेत. याची घोषणा मुख्यमंत्री आणि उपमुख्यमंत्र्यांनी केली. त्याचे मुंबईभर कौतुकही झाले. पण प्रशासनातील झारीतील शुक्रचार्य कोण आहेत उपमुख्यमंत्र्यांनी आदेश दिलेत. तात्काळ ते जीआर निर्गमित करावेत, अशी अपेक्षा व्यक्त केली. तसेच ५६ वसाहतींचे सेवा शुल्क, एसआरए भाड्याचाही विषय दरेकर यांनी मांडला. त्याचबरोबर कोकणात दरवर्षी मोठ्या प्रमाणात दरडी कोसळतात. त्यामुळे कोकणातील ३ ते ४ ठिकाणी आपत्ती निवारण केंद्र उभारावी, अशी मागणी केली. तर मशिदीवरील भोंग्यांच्या संदर्भात सुप्रीम कोर्टाने काही आदेश दिले

आहेत. १० ते ६ अशी वेळही दिली आहे. परंतु त्या आदेशाचे पालन होत नाही. पोलीस सांगतात आम्हाला गाईडलाईन नाहीत. आयुक्तस्तरावर बोलले जाते गाईडलाईन दिल्या आहेत. ४५ डेसिबलखाली आवाज असावा, या मुद्याकडेही दरेकर यांनी उपमुख्यमंत्र्यांचे लक्ष वेधले.

दरेकर यांच्या मुद्यांवर बोलताना उपमुख्यमंत्री देवेंद्र फडणवीस म्हणाले की, कोकणात कायमस्वरूपी आपत्ती निवारण केंद्रे उभारणार आहोत. त्याची व्यवस्था निश्चितपणे करण्यात आली आहे. एसआरए भाड्याच्या संदर्भात शासन विचाराधीन आहे. तसेच मशिदीवरील भोंग्यांच्या संदर्भात सुप्रीम कोर्टाच्या आदेशाचे तंतोतंत पालन केले जाईल. ज्या ठिकाणी पालन होत नाही, तेथे कारवाई
