SC sets aside... The petitioners have said that they represent the interest of about seven lakh families who are involved in the process of manufacture and sale of fireworks and are involved in the fireworks industry in one manner or another. They said if a blanket ban is imposed in this season on the sale and use of firecrackers in West Bengal, the sellers and manufacturers will have to suffer irreparable losses which may "lead to a complete shutdown of the firecracker industry altogether". The High Court in its order had said that the expression "firecrackers" will cover all types of sparklers as well as other similar materials, whether or not their bursting or burning involves any sound or light generation. The order had stated, "The state should ensure that there is no use or display or bursting of firecrackers of any type at all during Kali Puja, Diwali celebrations as well as Chhath Puja, Jagadhatri Puja, Guru Nanak's Birthday and Christmas and New Year's Eve celebrations this year." It said that only wax or oil-based diyas may be used for the occasions. On October 29, the top court had said celebration cannot be at the cost of others' health and clarified that while there is no total ban on the use of firecrackers, fireworks that contain Barium salts are prohibited. It had warned that top officials at various levels shall be held personally liable for any lapses. The top court had said it is unfortunate that

Babar Azam is the Pakistan team's captain in the T20 World Cup championship. Farooq's comments came after Khan in his Facebook post said "even though Pakistan has won the match, India has won our hearts" along with pictures of captains of both the teams, the FIR said quoting the complaint. ### Same sex Karwa...

The awareness programme was being carried out by the National Legal Services Authority, headed by the senior-most judge Justice UU Lalit, in collaboration with National Commission for Women and UP State Legal Services Authority. Justice Chandrachud said that awareness about the rights of women could truly be meaningful if it is created among the younger generation of men. "Awareness is not only a woman's issue. I believe that the deprivation of rights of women if we have to find an answer to them, the origin must be in the changing of mindset, both of men and women. True freedom for women, in other words, is truly intersectional," the judge remarked. He further said that there are real-life situations that show that there is a great divergence between ideals of the law and the real state of society. He said that even though legislations like the domestic violence act, prevention of sexual harassment at the workplace act have been enacted to achieve the goal of fulfilling the constitutional rights of women, the judges come across injustice against women every day. Justice Chandrachud stated that the entitlements which the law has created for women should not become a ruse or an excuse for perpetuating the domination of men. The apex court judge said the Constitution of India is a transformative document that seeks to remedy the structural inequalities rooted in patriarchy. "It has become a powerful tool to secure material entitlements and provide public affirmations of dignity and equality of women," he added.

### **Modi sets 2070...**

"Today the entire world acknowledges that India is the only big economy in the world that has delivered both 'in letter and spirit' on its Paris commitments. We are making all possible efforts in a resolute manner. We are working hard and we will show results," the Prime Minister said in a much-anticipated address. Presenting the country's national statement at the Summit, Modi listed out five commitments of India to combat climate change with a bold announcement that it will achieve the target of net zero emissions by the year 2070. He also raised the Nationally Determined Contribution (NDC) of achieving 450 giga watt non-fossil energy capacity to 500 giga watt. "India will increase its non-fossil energy capacity to 500 giga watt by 2030; India will fulfil 50 per cent of its energy requirements from renewable energy sources by 2030. Between now and 2030, India will reduce its total projected carbon emissions by 1 billion tonnes and by 2030; India will reduce the carbon intensity of its economy by 45 per cent and India will achieve the target of net zero by 2070," the prime minister said. "These five elixirs will be an unprecedented contribution by India towards climate action," he added. Modi also called for lifestyle changes which can go a long way in tackling climate change and urged to make 'Lifestyle for Environment' a global mission.

### Men-in-Blue don't...

Meanwhile, Gambhir's opening partner Virender Sehwag mentioned that India's body language wasn't great in the game against New Zealand and they need some serious introspection. "Very disappointing from India. NZ were amazing. India's body language wasn't great, poor shot selection and like few times in the past, New Zealand have virtually ensured we won't make it to the next stage. This one will hurt India and time for some serious introspection #IndvsNZ, " Sehwag said in a tweet. India have three matches remaining in the tournament and another loss will confirm their early exit from the competition. The Men in Blue will have to win their remaining matches by big margins to ensure their net run rate can be improved and they stand a chance at qualifying. They will next face Afghanistan in their third match on November 3 in Abu Dhabi in the hope of turning their campaign around in the mega event.

# Channi tries to outsmart Kejriwal in 'power' play

### To slash tariff by ₹3/unit for domestic consumers

**CHANDIGARH:** The Punjab cabinet on Monday decided to slash power tariff by Rs3 per unit for domestic consumers, a move which comes just months ahead of the Assembly polls and will put a burden of Rs3,316 crore yearly on the exchequer.

The announcement was made by Punjab Chief Minister Charanjit Singh Channi

(**pic**) after the Cabinet meet. "We are reducing power tariff by Rs3 per unit for domestic consumers," Channi told the media in Chandigarh. It is a "big Diwali gift" for people. The decision will come into effect immediately, the Punjab CM said.

# 11% DA FOR STATE EMPLOYEES

he Punjab Government on Monday announced an 11% hike in the dearness allowance (DA) for the state government employees. "On the occasion of Diwali, I wanted to give a gift to the state govt employees. They would have never had such a gift till date. The employees were on strike even before I became the CM. I spoke with them this morning," CM Channi was quoted saying.



## 'MISSION CLEAN' TO CURB SAND MINING, LIQUOR, DRUG TRADE

CHANDIGARH: Punjab Chief Minister Charanjit Singh Channi on Sunday announced "Mission Clean" in a meeting held with all the deputy commissioners and the senior superintendents of police (SSPs) of the state.

During the meeting, Singh directed officials to adopt a "'zero tolerance'" policy against corruption and take strict action against the sand, drug and liquor mafia.

"Chief Minister Charanjit Channi directs civil and police administration of the state to launch 'Mission Clean' by taking strict action against drug, sand and liquor mafia besides ensuring zero tolerance for corruption," tweeted the chief minister's office (CMO).

The Chief Minister also directed the mining department to ensure that sand and gravel should be available in the market at government rates while directing DCs and SSPs to keep a check on it. He also asked the mining department to ensure that no charges are levied on sand being used by panchayats for development works.

# Free pilgrimage to Ayodhya, other spots if AAP wins: Kejri

**PANAJI:** AAP national convener Arvind Keiriwal on Monday promised free pilgrimage to various religious centres, including Ayodhya and Ajmer Sharif, if his party is voted to power in Goa in the Assembly poll due in next February, which he said is a "third guarantee" being given by AAP to Goans.

Addressing a press conference here, Kejriwal alleged the BJP was trying to protect Goa chief minister Pramod Sawant despite allegations of corruption being levelled against him by former governor Satya Pal Malik. "When we announce the poll guarantees, people ask me from where will I get funds. Former governor Satya Pal Malik has given a reply to it,"

the Delhi chief minister said. The governor has said during his 1-year tenure (in Goa), he saw a largescale corruption, Kejriwal said while referring to Malik's recent interview to a news channel. PC draws analogy with cricket to slam rising fuel **prices:** Petrol and diesel prices in the country have



perhaps crossed the century mark as the Modi government thinks not too many centuries are being scored in cricket these days, former Union finance minister P Chidambaram quipped.

In a press meet in Panaji, he said it was surprising the Central government raised fuel prices even during the festive occasion of Diwali. "Today — unexpectedly, be-

cause I thought on the eve of Diwali, they wouldn't do this —the govt has once again announced an increase in prices. As of yesterday (Sunday) night, the prices of petrol and diesel have touched unprecedented levels. It (petrol) is Rs115 per litre in Mumbai and Rs 120 in some places in Rajasthan like (Sri) Ganganagar. In Goa, it is Rs106 a

litre," Chidambaram said.

Yogi during a private media interaction a few days ago had asked, "Why is Congress not appointing a common woman as the party chief?'

Congress spokesperson Supriya Shrinate said, "Yogiji you are upset about Priyankaji's decision to give 40% tickets to women. You had opposed the women quota Bill in Parliament, you don't have any woman cabinet minister in your council, you want to control women power. Better change your mindset."

Yogi's cabinet has 3 women ministers — Swati Singh, Gulab Devi and Neelima Kativar, who have MoS rank. Singh is MoS with independent charge of women and child welfare. Gulab Devi is MoS for secondary education. Neelima Katiyar is MoS for higher education, science and technology. Ahead of the Assembly poll, Congress is trying hard to woo the women who form half of the UP population.
