
## Limited Review Report On Quarterly and Nine months ended Financial Results of the Company Pursuant to the Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

To the Board of Directors Pearl Polymers Ltd.

- 1. We have reviewed the quarterly and nine months ended financial results of M/s Pearl Polymers Limited ('the company') for the quarter and nine months ended December 31, 2024 which are included in the accompanying "Statement of financial results for the quarter and nine months ended December 31, 2024 (the "statement"). The Statement has been prepared by the company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ('the Regulation'), read with SEBI Circular No. CIR/CDF/FAC/62/2016 dated 5<sup>th</sup> July 2016 ('the Circular') which has been initiated by us for identification purpose. - 2. - 4.
