(सीआईआई) के अनुसार माल व सेवा कर संग्रह, रेल माल दुलाई यातायात समेत पेट्रोल खपत, बिजली मांग, इलेक्ट्रॉनिक पथकर संग्रह व अन्य संकेतक पुनरुद्धार के संकेत दे रहे हैं। उद्योग मंडल ने कहा- हालांकि अभी कुछ कहना जल्दबाजी होगी लेकिन ये निश्चित रूप से अच्छे संकेत हैं जो पूर्णवृद्धि के बाद तीव्र गति से पुनरुद्धार का इशारा कर रहे हैं। सीआईआई के महानिदेशक चंद्रजीत बनर्जी ने कहा कि इस शुरुआती पुनरुद्धार को आगे बढ़ाने के लिए जरूरी है कि अनिश्चितताएं दूर हों जो अभी पाबंदियों के संदर्भ में बरकरार हैं।
