Sub.: Disclosure of reasons for delay in submission of Financial Results for the Quarter and Nine Months ended 31st December, 2020, pursuant to the SEBI Circular CIR/CFD/CMD1/142/2018 dated 19th November, 2018

Dear Sir/Madam,

In terms of Regulation 33(3) of the SEBI (LODR) Regulations, 2015, Rollatainers Limited (the "Company") is obliged to submit and/or publish the financial results **for the quarter and Nine months ended on 31st December, 2020** on or before 14th February, 2021. However, the Company is not in a position to publish the said results in a timely manner. Therefore, in compliance with the SEBI circular dated 19th November, 2018, the Company would like to furnish the reasons for delay in publishing of financial results as under:

Due to some unavoidable circumstances, it has become difficult for the management as well as other senior officials of the Company to finalise the Financial Results (Standalone and Consolidated) of the "**Rollatainers Limited**" on time and disseminate the same in compliance with the Regulation 33(3) of SEBI (LODR) Regulations, 2015.

But further we would like to inform you that we have already intimated the stock exchange vide Ref No. RTL/BSE/NSE/2020-21 dated 5th February 2021 regarding the Board Meeting which was scheduled to be held on 13th February 2021 and dated 12th February 2021 regarding postponement of the Board Meeting which is now rescheduled to be held on 18th February 2021 to consider, approve and take on record the Standalone and Consolidated Unaudited Financial Results of the Company for the Quarter and Nine Months ended on December 31st, 2020.

It is also submitted that due to the Wuhan Virus pandemic (COVID-19), the governance become difficult and cumbersome for the Corporates to manage. Despite this, we have tried our best to follow the compliances in true letter and spirit.

In view of above you are hereby requested to condone the delay and provide relaxation from penal provisions for and on account of delay in submission of results.

We request your good office to consider our submission favourably and oblige.
