Dear Sir,

I, **Megha Samdani**, proprietor of M K Samdani & Co., Company Secretaries, Ahmedabad, have been appointed as Scrutinizer of **AVIVA INDUSTRIES LIMITED** (CIN: L51100MH1984PLC034190) ("the Company") read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended, to conduct the remote e-voting process in respect of the below mentioned resolutions proposed at the Annual General Meeting ("AGM") of the Aviva Industries Limited on Friday, September 30, 2022 at 5:00 P.M. (IST) through VC/OVAM.

1. 4. The shareholders' holding shares on the cut-off date i.e. September 23, 2022, were entitled to vote on the proposed resolution(s) (Item No. 1 to 5 as set out in the notice of the AGM of the company)

5. Accordingly the electronic votes cast were taken into account and on 29th September, 2022 (around 5:00 PM); thereafter e-voting portal was blocked for voting by NSDL.

6. After the conclusion of the Annual General Meeting of the Company, the votes were unblocked in the presence of two witnesses who are not in employment with the company and a final electronic report was generated by me. The data generated was diligently scrutinized.
