The Chairman welcomed the members to the meeting and informed that as the requisite quorum is present, the meeting is in order. The Registers as required under the Companies Act, 2013 and other statutory documents as per the resolutions are kept open for inspection of the members electronically. There are no qualifications or observations in the Statutory/Secretarial Auditors' Report. The Directors present and the KMPs introduced themselves. The Statutory Auditors, Secretarial Auditors and Scrutinizer were also present in the meeting. The Chairman gave a brief overview of the operations of the Company, updates about the ongoing expansion and the business outlook. Thereafter, he proceeded to take up the business as stated in the notice of the meeting. He also informed that the Company had provided the facility of e-voting to the members on all the resolutions in compliance with the provisions of Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, Section 108 of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administration) Rules, 2014 and requested the members who have not voted during the remote e-voting period to cast their vote. The e-voting commenced on 21<sup>st</sup> August, 2023 at 9.00 a.m. and ended on 23<sup>rd</sup> August, 2023 at 5.00 p.m.

Shri Martinho Ferrao was appointed as the Scrutinizer to supervise the e-voting process. Members who were present at the AGM through VC / OAVM and had not casted their votes electronically
