## EC guidelines: gloves for voters and thermal scanners in booths

PATNA, NEW DELHI, AUGUST 21

VOTERS WILL be provided with gloves to press the EVM button and Covid-19 patients in quarantine will be allowed to vote at the last hour of the polling day, according to broad guidelines issued by the Election Commission (EC) on Friday for holding elections during the pandemic. The gloves will most likely be disposable.

A separate set of guidelines would be issued for voters who are residing in areas notified as "containment zone", the EC said.

The commission has recommended mandatory sanitisation of polling stations, preferably a day before the polls.

Thermal scanners would be placed at the entry point of every polling station. Polling or paramedical staff will conduct thermal screening of voters at the en-

try point of a polling station, it said. "There shall be maximum 1,000 electors instead of 1,500 electors in a polling station." the

A group of five people, including candidates but excluding security personnel, is allowed to take part in door-to-door campaigning.

For roadshows, the commission said, convoys of vehicles should be broken after every five vehicles instead of 10 (excluding security vehicles).

Public gatherings and rallies can be held subject to adherence to Covid-19 guidelines.

The district election officer should identify in advance dedicated grounds for public gatherings with clearly marked entry and exit points.


In all such identified grounds, the district election officer should put markers in advance to ensure social distancing norms are followed by the atten-

The district election officer and district superintendent of police should ensure that the number of attendees does not exceed the limit prescribed by the State Disaster Management Authority for public gatherings, the commission said.

Bihar will be the first state where assembly elections will be held amid the pandemic. The polls are likely to be held sometime in October-November.

According to sources, elections could be held in Bihar in two or three phases. The Chief Electoral Officer will be holding an online meeting with all district magistrates on Monday.

A district magistrate told The Indian Express, "A voter will have to use a mask and will be provided gloves. Pressing the EVM button could be the only direct touch during the voting process.

# Public gathering banned, Rupani urges people to celebrate at home

A DAY ahead of Ganesh Chaturthi festival, Gujarat Chief Minister Vijay Rupani urged people to celebrate the festival by placing Ganesha idols in their homes in the wake of Covid-19 pandemic even as Gujarat Police put prohibition on any public religious event or procession on

According to Gujarat Police officials, there is a prohibition on any public gathering for idol establishing, processions including Shobha Yatra and Visarjan Yatra, religious or cul-

tural programs, fairs and others at public places including societies and mohallas.

"I wish that Bhagwan Ganesh known as Vighnakarta to remove all the obstacles and hurdles including the spectre of novel coronavirus and make our lives strong, progressive, developed, happy and prosperous. I urge my fellow citizens to install eco-friendly idols of Ganesha at their homes for prayer and offerings and maintain social distancing and other protocols (sic)," read a statement from the office of Rupani.

In Ahmedabad, a notification issued by Ahmedabad city Police Commissioner Sanjay Srivastava on August 10 read, "The guidelines issued by the union government and Gujarat government regarding Disaster Management Amendment Act will be in place. All sorts of public religious, cultural, entertainment and educational programs with regard to the festival will be prohibited. There is prohibition on establishment of idols in public places including societies and mohallas by any committee and those who have established idols in their homes must do 'visarjana' in their homes only. No permission is needed for establishing idols by individuals in their personal manner and no permission

will be given by police for any

public ceremony including visarian. Eldery citizens, pregnant women and children below the age of 10 are appealed to stay at homes unless necessary. All citizens will be wearing masks and maintain social distancing of two feet at public places. Any police officials from the level of unarmed head constable of Ahmedabad city police can book violators of the order under Indian Penal Code Section 188 for disobedience (sic).'

A senior police official with the Gujarat DGP office also confirmed to The Indian Express that there will be prohibition across the state on public gathering during Ganesh Chaturthi.

#### TRIPLE MURDER IN **PORBANDAR**

### Forest guard sent to 7-day police custody

FOREST GUARD Lakhman Odedra was Friday sent to seven-day police remand by a local court in Porbandar in connection with the alleged murder of fellow forest guard Hetal Solanki, her husband and daily-wager of the forest department inside Barda Widlife Sanctuary early this week.

"We produced him in a court with an application seeking his remand on the ground that the wooden club with which the accused beat the three victims to death was yet to be recovered and that he was beating around the bush over his relationship with the fellow guard. Granting our plea, the court gave us custody of the accused for seven days," Smit Gohil, deputy superintendent of police of Porbandar (rural) division, told The Indian Express.

Hetal Solanki, the forest guard of Godhana beat in Bhanvad range forest of Barda sanctuary, her husband Kirti, and daily-wager Nagajan Agath were found dead on Monday morning.

Police said that 32-year-old Odedra and 30-year-old Hetal had become 'friends' when they were working together around two years ago and Odedra wanted to convert that 'friendship' into a 'strong relationship' but that had strained married life of Odedra and Manju.

"He is beating around the bush over the nature of his relationship with Hetal. But we have obtained call data records of his mobile phone and are analysing them for clues. We have not recovered the wooden club with which he had hit the three victims in their heads. Now, that we have his custody, we shall do the reconstruction of the crime to understand as to how he had committed the murders," Gohil, who is investigating officer of the case, further said.

Gohil added that at present, they were not treating Odedra's wife as an accused in the case.

## Girl caught plucking flower, Odisha village boycotts all 40 Dalit families

FORTY DALIT families in Kantio Kateni village of Odisha's Dhenkanal district have been subjected to social boycott for the past two weeks after a 15year-old girl from the community plucked flowers from the backyard of an upper caste family two months ago.

After one family registered its objection, the matter snowballed into a confrontation between the two communities, eventually leading to the social boycott of the 40 Dalit families, locals said.

The girl's father Niranjan Naik said, "We had immediately apologised so that the matter could be resolved, but following the incidents, several meetings were called and they decided to boycott us. Nobody is allowed to talk to us: we are not allowed to participate in any social event of the village.'

The village, which has nearly 800 families, has 40 families from the Scheduled Caste Naik community.

The community submitted memorandums to the district administration and the police station concerned on August 17.

"The (local) PDS dealer and the provision store owner have stopped selling to us, forcing us to walk at least 5 km to buy essentials. Villagers have even stopped talking to us," Jyoti Naik, one of the villagers, said.

The memorandum states that they have been deprived of sharecropping to make sure "that our people do not get apple work in the village" and have to move in search of work, "Most of our people are semi-literate



## ITIHAS tracks Covid cases in Gujarat using mobile network, artificial intelligence algorithm



Based on tracing the locations visited in 14 days by a patient prior to his/her testing positive and the duration spent at the said locations, a score is generated for mobile towers across the city (indicated by black spots). Superimposed on the city map, higher the score, higher the priority becomes for AMC to conduct surveillance activities. Black spots are the towers and the number is the score on which basis the AMC

prioritises its surveillance exercise. So, as per this map of the North West zone of Ahmedabad, 135 gets priority over 66.

FIVE MONTHS after the first Covid-19 case was reported from Guiarat. the govlected via ITIHAS (IT-enabled Integrated Hotspot Analysis System) developed by an IIT-Madras professor, for surveillance and containment strategies, apart from manual contact tracing.

ITIHAS is a predictive, back-end tool to fine-tune Aarogya Setu data "strictly for surveillance purposes", according to Ahmedabad Municipal Corporation (AMC) officials.

In Gujarat, it was first used in Ahmedabad from May 23, and is now expanded to Surat, Vadodara, Rajkot and Navsari districts, while also being used for state-wide prediction of emerging hotspots. According to the Gujarat health department, as of August 19, there are 883 emerging hotspots across the state. This tool takes data via two channels

once a patient tests positive — one from ICMR, the nodal agency

which is notified of positive cases tested in labs, or via Aarogya Setu application depending on the declaration and self assessment by the user. At a media presenta-

tion on Thursday, principal secretary, health and family welfare, Jayanti Ravi, called the tool a "game-changer in surveillance activities... with an intelligent way of pinpointing (areas) by use of a complex, artificial intelligence algorithm". However, an AMC official on condition of anonymity opined that the tool "may see privacy concerns".

AMC that has used ITIHAS the longest with constant feedback, now sees an improved version and accuracy. It uses mobile network tower pings, which are around 11,000plus across Ahmedabad, divided across the 133 pincode areas. Once tested positive,

the tool traces the movement of the patient's past 20 days and based on duration spent calculated by mobile pings sent to the tower, an exposure score is calculated, which

is further fine-tuned and mapped geographically to undertake surveillance ac-

Analysts from Raksha Shakti University in Gandhinagar, coordinate with a team of professor V Kamakoti from IIT-Madras who then processes the raw data and reverts to AMC and AUDA (Ahmedabad Urban Development Authority) officials. Kamakoti was among the developers of Aarogya Setu app.

Ravi, also said while Aarogya Setu is not mandatory on the user-end for the tool to function on the back-end, although it was recommended to be downloaded. This can be attributed to the fact that each phone device pings off a tower, regardless of Aarogya Setu.

According to the state health department, as of August 19, there has been nearly 94 lakh Aarogya Setu downloads in Gujarat. ITIHAS has been used for identifying 4,696 hotspots till date.

The Gujarat government had earlier this week told the Gujarat High Court that is hearing Covid-19 related petitions about Surat Municipal Corporation using the ITIHAS tool.

Rajkot municipal commissioner Udit Agrawal says ITIHAS has been in use in Rajkot for a month. "On August 15, there was presence of people with Covid-19 in range of 192 towers of mobile phones. Within two days, we managed to eliminate 53 towers from the list by intense contact tracing and sending our Dhanvantri Raths for surveillance and screening," Agrawal told The Indian Express.

He added that thanks to the timely alert by the ITIHAS system, the health department of Rajkot Municipal Corporation managed to reduce the the score of positive persons by 300 in five tower locations, in the range of 200-300 in 10 tower locations, and in the range of 100 - 200 in 45

"Overall, there was reduction of cases in 127 towers (range). The score increased in case of 11 towers but one of them is near a Covid care centre, the other near the PDU Hospital and the remaining in busy commercial areas," Agrawal said.

A top AMC official said, "Based on this (detection with the help of Aarogya Setu linked to ITIHAS), along with intelligence surveillance of CDR details of mobile numbers through mobile tower locations of an infected person's movement, the areas that require surveillance and testing are decided on a daily basis."

The official added that an authentic mobile number was sufficient to track a Covid patient and accordingly plan surveillance and testing. To authenticate this data the AMC mandated OTPs to be shown at private and government testing

"Incorrect addresses and mobile numbers shared by residents before testing make it impossible to track the person if he is tested positive. Every tested resident will have a confirmed mobile number which will automatically assist in track-

ing," the AMC official said. According to a health official, the AMC limits contact tracing to 10 persons per positive patient on an average. "There is little point of contact-tracing when we have crossed 20,000 cases. With limited resources, we have to prioritise among testing, treating, containment, surveillance and contact-tracing," the official told The Indian Express.

Secretary, Education Vinod Rao who is deployed as Officer on Special Duty at Vadodara finds Aarogya Setu "sufficient" to contain Covid-19. "The only solution is maximum surveillance and isolation of people with symptoms," he says.

SMC health department does active and passive surveillance by the Jamini application launched around two-and-half years ago, to track malaria cases, now used to track suspected Covid-19 cases, and the Covid-19 tracker for Android

Medical Officer of Health at SMC, Dr Swapnil Patel, who handles the Jamini application, says, it is largely used by doctors who keep a log of their patients' medical history. "We have registered 1,734 private clinics, 675 private hosptials, 51 urban health centres, 35 radiologists centres, and 100 private laboratories in Surat city," says Dr Patel. Till date 1.58 lakh ARI cases have been reported through Covid-19 Tracker, of which over 21,000 patients were referred to hospitals.

Through Radiology centre details, over 14,425 patients had been registered on Jamini. "Daily we get 1,500 to 1800 patients registered under Jamini app," says

Surat Deputy Health commissioner Dr Ashish Naik said, "The Covid-19 tracker application works on TTT strategy (Tracking, Testing, Treatment). This application is also useful to track and monitor
