भीषण दुर्घटनेत चालकाचा जागीच मृत्यू; दोघे जखमी दिवसभर वाहतूक कोंडी

वसईत महामार्गावर कंटेनरचा अपघात

ः मुंबई-अहमदाबाद महामार्गावर वसई पूर्वेकडील सुवी पॅलेस सकाळी सहा वाजता झालेल्या दोन कंटेनरच्या अपघातामुळे हॉटेलसमोर आज सकाळी सहाच्या मंबई-अहमदाबाद महामार्गावर 'चक्का जाम' झाला होता. सायंकाळी ५ वाजेपर्यंत वाहतूक कोंडी झाली होती. वाहनांच्या लांबच्या लांब समारास दोन कंटेनर एकमेकांवर रांगा लागल्या होत्या. कंटेनरमध्ये असणाऱ्या लोखंडी पट्ट्या व अन्य धडकल्याने भीषण अपघात झाला. साहित्य रस्त्यावर पडल्याने मार्ग बंद झाला होता. वजनदार सामान या अपघातामध्ये एका कंटनेर उचलण्यासाठी पोलिसांनी जेसीबी आणले; मात्र तरीही काही वजनी चालकांचा जागीच मृत्यू झाला सामान उचलण्यास अडथळा निर्माण होत होता. याच दरम्यान कोंडी आहे; तर एक दोन जखमी झाले वाढत असल्याने मुंबईकडे जाणाऱ्या वाहनांसाठी एका बाजूने मार्ग सुरू आहे. या घटनेची माहिती मिळताच करण्यात आला, तरीदेखील सायंकाळी ५ वाजेपर्यंत वाहनचालकांना पोलिसांनी घटनास्थळी धाव घेतली. वाहतूक कोंडीचा सामना करावा लागला. मिळालेल्या माहितीनुसार, वसई

पूर्वेकडील महामार्गावर सुवी पॅलेस हॉटेलसमोर असणाऱ्या पुलाखालून पोलिस व वाहतूक विभाग कर्मचारी गुजरातच्या दिशेने कंटेनर जात घटनास्थळी दाखल झाले. अधिक होता. त्याने दुभाजक तोडून दुसऱ्या तपास पोलिस करत आहेत. चालक कंटनेरला जोरदार धडक दिली. यात सूरजसिंग अमरसिंग सामरा (५२) एका कंटनेर चालकांचा मृत्यू झाला. याचा अपघातात जागीच मृत्यू झाला याची माहिती मिळताच वालीव असून दोन जण जखमी झाले आहेत.
