

alaysia's AirAsia Bhd on Tuesday said it is evaluating its lossmaking budget airline joint venture in India with Tata Sons Ltd in the wake of the financial distress due to the coronavirus pandemic.

"Our businesses in Japan and India have been draining cash, causing the group much financial stress. Cost containment and reducing cash burns remain key priorities evident by the recent closure of AirAsia Japan and an ongoing review of our investment in Air-Asia India," the airline said in a statement on Tuesday.




