Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“the Listing Regulations”), we are pleased to inform that Dalmia Cement (North East) Limited (formerly, Calcom Cement India Limited) has approved capital expenditure to the tune of Rs.3,642 Crore for setting up of:

- (a) new clinkerisation unit of 3.6 MTPA at its Umrangso unit, and
- (b) new cement grinding unit of 2.4 MTPA at its Lanka unit.

Dalmia Cement (North East) Limited is a step-down subsidiary of the Company and a subsidiary of Dalmia Cement (Bharat) Limited (DCBL, a subsidiary of the Company).
