- I, CS J. J. Gandhi, Proprietor of J J Gandhi & Co. - 2. The Company has given the Public Advertisement with respect to email of Postal Ballot Notice in English language in the newspaper "Financial Express" dated 8th October, 2023 (Ahmedabad edition) and in Gujarati language in the news paper "Loksatta Jansatta" (Vadodara edition) dated 8th October, 2023.
