THE SECURITIES AND Exchange Board of India (Sebi) on Tuesday issued a demand notice of ₹3.12 crore to Chitra Ramkrishna, former managing director and chief executive officer of the National Stock Exchange (NSE), over governance issues at the exchange. The notice came in after Ramkrishna failed to pay the fine imposed on her by the markets regulator.

"A sum of ₹3,12,01,000/-(Rupees Three Crore Twelve Lakh One Thousand only) along with further interest, all costs, charges and expenses incurred in respect of all the proceedings taken for recovery of the said sum is due to Sebi from you (Ramkrishna)," Sebi said on Tuesday.

The regulator has asked Ramkrishna to pay the amount within 15 days of the notice. In case of non-payment, the regulator has warned of arrest and attachment of assets and bank accounts of the former NSE chief. On February 11, Sebi had slapped a fine of ₹3 crore on Ramkrishna for matters including the appointment of Anand Subramanian as the group operating officer (GOO), and sharing of sensitive information about the exchange with an unknown person.

Sebi further stated that Ramkrishna was no longer competent to mortgage, charge, lease or otherwise deal

of demand were sent to Ravi Narain, former CEO at NSE, and Subramanian. However, in April, the Securities Appellate Tribunal (SAT) granted an interim relief to Ramkrishna and asked her to deposit only ₹2 crore within six weeks. "If such an amount is deposited, the balance amount shall not be recovered during the pendency of the appeal," said SAT members. It further ordered NSE to deposit ₹4.73 crore towards leave encashment and deferred bonus of Ramkrishna in an escrow account, and not in the Investor Protection Fund Trust.

The Appointed Date for the Scheme is April 1, 2022 or such other date as directed by the Hon'ble Chandigarh Bench of the National Company Law Tribunal ("NCLT"). The Scheme is subject to receipt of regulatory and other approvals inter-alia approval from BSE Limited, National Stock Exchange of India Limited, SEBI, shareholders, creditors, NCLT and others, as may be applicable.

Pending regulatory approvals and other compliances, the financial results of the Company does not have impact of the scheme. Expenses related to the Scheme have been recognised as an exceptional item in the consolidated financial results.

The above consolidated results include revenue from operations from CLG Business Undertaking for the quarter and year ended March 31, 2022 of Rs. 2,956,70 Million and Rs. 11,309,92 Million respectively. During the financial year 2019-20, the Group decided to divest NIT Learning Systems Limited (NLSL) [Formerly known as Mindchampion Learning Systems Limited], to a strategic or financial investor. Therefore,

as per provisions of Ind AS 105 - 'Non-current assets held for sale and Discontinued Operations', the results of NLSL were classified as loss from discontinued operations. The Board of Directors in its meeting held on January 28, 2022 decided not to pursue the process of divestment of NLSL and leverage its assets and resources of the company for its offerings in the education sector

and house the CLG Business Undertaking under the Scheme as stated in note 4 above. Consequently, as per Ind AS 105, the financial results including assets and liabilities of NLSL have been reclassified as continuing operations with corresponding restatement in the previous financial results. The Company on February 19, 2020 had approved the proposal of voluntary liquidation as shareholder of NIIT Institute of Process Excellence Limited (NIPE) and NIIT Yuva Jyoti Limited (NYJL), wholly owned

subsidiaries, in accordance with applicable laws, as recommended by the board of directors of these subsidiaries. During the financial year 2021-22. NCLT vide its order dated February 25, 2022, read with the rectification order dated March 23, 2022 approved the dissolution of NYJL with effect from February 25, 2022. Consequent to the above, all the shares held by the Company in NYJL were cancelled. Consequently, based on the expected return on investments as per future business plan, the Company has recognised Deferred Tax Asset of Rs. 179.51 Million on long term capital losses on cancellation of shares of NYJL. The voluntary liquidation of NIPE is in progress.

Oyo to shelve IPO plans in 2022 amid market volatility



An IPO delay would mark another setback for Oyo and founder Ritesh Agarwal

OYO HOTELS, THE once high-flying Indian startup, is shelving plans for an initial public offering (IPO) in 2022 after a market downturn that would hurt its valuation, according to people familiar with the matter. The board of Oyo, formally known as Oravel

Stays, talked through a change in the offering's timing during multiple meetings last week and earlier this week after consulting with its bankers and investors, said the people, asking not to be identified because the decisions aren't yet public. If the company picks up the process again by year-end, the earliest possibility for an IPO would be in 2023, they

The Gurugram-headquartered company, which filed preliminary IPO documents last year, is seeking regulatory permission to update its draft prospectus with fresh financial information after the close of the September quarter, said the people. Its bankers, led by Kotak Investment Banking, have filed the request with the Securities and Exchange Board of India, the people said.

The decision could make Ovo's IPO a high-profile casualty from a global downturn in the technology industry. With inflation fears rising, lingering Covid-19 infections and the war in Ukraine, investors have roiled markets and pulled back from risky investments. The tech-heavy Nasdag index has tumbled 26% this year.

"This isn't the best of times for any IPO," said Ashutosh Sharma, head of research, Forrester Research. "Why Oyo, any start-up anywhere in the world looking to raise money through IPO, VC funding or PE placement or any other channel, won't get the best valuation."

An IPO delay would also mark another setback for Oyo and founder Ritesh Agarwal, once celebrated for their vision of changing the hotel and lodging industry by backers like SoftBank Group founder Masayoshi Son. SoftBank holds about 47% stake in the start-up, while the 28-year-old chief executive officer owns about one third.

Ovo has yet to hear back from the securities regulator on its request, but indications are that it will get a response either late this week or next week, said one of the people. Oyo filed its preliminary document, the so-called Draft Red Herring Prospectus or DRHP, for a \$1.1-billion IPO in September last year, and about eight months have since lapsed without the IPO being cleared.

If it gets a green light from the regulator, the start-up will seek to file as an addendum five or six pages of financials for the fiscal year that ended in March, as well as for the six months through September, said the people. -BLOOMBERG

The Scheme is subject to receipt of regulatory and other approvals inter-alia approval from BSE Limited, National Stock Exchange of India Limited, SEBI, shareholders, creditors, NCLT and others, as may be applicable.

Pending regulatory approvals and other compliances, the financial results of the Company does not have impact of the scheme. Expenses related to the Scheme have been recognised as an exceptional item in the consolidated financial results.

The above consolidated results include revenue from operations from CLG Business Undertaking for the quarter and year ended March 31, 2022 of Rs. 2,956.70 Million and Rs. 11,309.92 Million respectively.

During the financial year 2019-20, the Group decided to divest NIT Learning Systems Limited (NLSL) [Formerly known as Mindchampion Learning Systems Limited], to a strategic or financial investor. Therefore, as per provisions of Ind AS 105 - 'Non-current assets held for sale and Discontinued Operations', the results of NLSL were classified as loss from discontinued operations. The Board of Directors in its meeting held on January 28, 2022 decided not to pursue the process of divestment of NLSL and leverage its assets and resources of the company for its offerings in the education sector and house the CLG Business Undertaking under the Scheme as stated in note 4 above. Consequently, as per Ind AS 105, the financial results including assets and liabilities of NLSL have been reclassified as

continuing operations with corresponding restatement in the previous financial results. The Company on February 19, 2020 had approved the proposal of voluntary liquidation as shareholder of NIIT Institute of Process Excellence Limited (NIPE) and NIIT Yuva Jyoti Limited (NYJL), wholly owned subsidiaries, in accordance with applicable laws, as recommended by the board of directors of these subsidiaries. During the financial year 2021-22, NCLT vide its order dated February 25, 2022, read with the rectification order dated March 23, 2022 approved the dissolution of NYJL with effect from February 25, 2022. Consequent to the above, all the shares held by the Company in NYJL were cancelled. Consequently, based on the expected return on investments as per future business plan, the Company has recognised Deferred Tax Asset of Rs. 179.51 Million on long term capital losses on cancellation of shares of NYJL.
