The DP has also been directed not to execute any contra-trade of any number of securities of the Company during the next six months from the end of the month in which, 1,00,000 shares of the Company was purchased by MFPL from open market during the window closure period, i.e. till 30th November, 2022 and shall strictly observe and abide by the Company's Code on Insider Trading and the SEBI (PIT) Regulations at all times, failing which would result in more stringent disciplinary action.
6	Reasons recorded in writing for taking action stated above	The matter was placed before the Audit Committee. After discussion with the committee members, the Chairman of the Audit Committee decided that, though the said transaction took place due to sheer inadvertence as clarified by the DP, however depending on the value and fact that the DP being a promoter group entity has violated the
