Sub: Report of Scrutinizer for the Postal Ballot Process vide Notice Dated12th January, 2022 under section 110 and 108 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014 by W.S. INDUSTRIES (INDIA) LIMITED ('the Company')

In the meeting of the Board of Directors of W.S. INDUSTRIES (INDIA) LIMITED held on 12th January, 2022, I, Mrs. Lakshmmi Subramanian, Senior Partner of M/s. Lakshmmi Subramanian & Associates Practicing Company Secretary's, was appointed as Scrutinizer for Postal Ballot as per section 110 of the Companies Act, 2013 ('Cos Act') for passing of the item of business as special resolution by the members of the Company:

The Company has availed the e-voting facility from National Securities Depository Limited for the shareholders to cast their votes to the aforesaid resolution through electronic mode in addition to voting through duly filled in paper postal ballot forms under Section 110 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014which recognizes voting by electronic mode for postal ballot and, which prescribes the appropriate mechanism for e-Voting.

The postal ballot process was accordingly conducted and concluded as below:

- The Company on 20th January, 2022 dispatched the notice under section 110 of the Companies Act, 2013 through registered post for physical Postal ballot and through e-mail to all the members of the Company whose names appeared on the Register of Members/ List of Beneficiaries as on 14th January, 2022.
- The Company issued an advertisement in Business Standard and Makkal Kural about the dispatch of Postal ballot Notice on 21st January, 2022.
- The e-voting process commenced on Saturday, 22<sup>nd</sup> January, 2022 (09.00 A.M.) and was open up to the close of working hours at 17.00 hours IST on Sunday, 20<sup>th</sup> February, 2022
- All electronic votes received up to the close of working hours at 17.00 hours IST on 20th February, 2022, being the last date and time fixed by the Company for receipt of Postal Ballot, either physically or electronically, were considered for my scrutiny.
- The votes cast by the members through electronic voting system was downloaded and collected from the website www.evoting.nsdl.com and the votes cast through
