# K'taka high schools reopen with caution

After a near week-long hijab row forced holiday, high schools in Karnataka reopened on Monday amid prohibitory orders in Udupi, which witnessed violence and tension last week, and sensitive areas of Dakshina Karnataka and Bengaluru. Section 144 of the Criminal Procedure Code has been imposed in sensitive areas in the said districts.

In Udupi district, all the schools that reopened witnessed normal attendance. Education Department sources said Muslim girls students who reached the school campuses wearing hijab and removed them before entering classes. Examinations scheduled for the day are also going on in the institutions.

The district administration has imposed Section 144 of CrPc around 200-metre radius of all high schools in the district from Monday to Saturday to maintain peace. Udupi tehsildar Pradeep Kurudekar, who visited a few schools, said Muslim students were abiding by the high court's interim order by removing hijabs before entering classes. There were no reports of Hindu students turning up in saffron shawls. The police have been posted in Udupi town and near the schools to maintain law and order and to avoid any un-

toward incident.

In a statement, Udupi Pejawar mutt chief Swami Vishwaprassana Teertha appealed to all sections to avoid chaos and maintain peace. In some government schools in Koppal and Kalaburagi districts, students appeared in classrooms wearing hijab as well as burqa, sources in the Education Department said. However, officials who reached the spot later asked the students to remove them.

In Shivmogga, a few students insisted that they should be allowed to go inside the schools wearing burqa despite instruction by the school authorities not to enter the premises wearing either hijab or burqa as the high court has restrained them from doing so. They were not allowed entry into the school citing the HC order, even as the girls feigned ignorance about the court order. Subsequently, there was an argument between teachers and students.

## Allow hijab matching with uniform, say students

Challenging the government order restricting the use of any cloth that can disturb peace, harmony and, law and order, the girls who petitioned in favour of hijab requested the Karnataka High Court on Monday to allow them to wear hijab of the colour of the school uniform. The girls made the plea to the full bench of the high court comprising Chief Justice Ritu Raj Awasthi, Justice JM Khazi and Justice Krishna M Dixit. "I am not only challenging the government order, but also asking for a positive mandate for allowing me to wear a headscarf of the same colour of the uniform," advocate Devadatt Kamat, appearing on behalf of the girls of the government pre-university college in Udupi, told the bench. Kamat also claimed that the central schools permit Muslim girls to wear headscarves of the school uniform colour and the same could be done here. According to him, headscarves are an essential religious practice, and restricting its use was violating Article 25 of the Indian Constitution.

## SC approves CBI probe into TN student's suicide

**NEW DELHI:** The Supreme Court on Monday allowed the CBI to proceed with the probe into the suicide of a 17-year-old girl in Thanjavur who was allegedly coerced to convert to Christianity. A bench of Justices Sanjay Khanna and Bela M Trivedi issued notice on the appeal filed by the Tamil Nadu DGP challenging the Madras High Court order. The apex court said there were two aspects in the matter -- one, there are certain observations recorded in the impugned judgment and the second is regarding the final order directing probe by CBI. The court said it might not be appropriate for it to interfere in the CBI investigation but it would issue notice on the first aspect.

## Govt blocks 54 more...

The banned apps include Beauty Camera: Sweet Selfie HD, Beauty Camera - Selfie Camera, Rise of Kingdoms: Lost Crusade, Viva Video Editor, Tencent Xriver amongst others. Other apps that have been banned, as per fresh orders, include Arena Free Fire - Illuminate, Astracraft, FancyU pro, MoonChat, Barcode Scanner - QR Code Scan, and Lica Cam. The crackdown marks the first such step taken this year after a massive sweep against the Chinese apps in 2020. In June 2020, the govt had banned 59 apps with Chinese links, including hugely popular TikTok and UC Browser, saying they were prejudicial to sovereignty, integrity and security of the country.
