Sub: Report of Scrutiniser on the results of voting conducted through postal ballot ("Postal Ballot") by way of remote e-voting ("e-voting / remote e-voting").

Dear Sir,

1. I, Savita Jyoti of M/s. Savita Jyoti Associates, Company Secretaries, was appointed as the Scrutiniser by the Board of Directors of Vascon Engineers Limited ("the Company"), pursuant to the provisions of Section 110 and other applicable provisions, if any, of the Companies Act, 2013 ("the Act") read with the Companies (Management and Administration) Rules, 2014 and pursuant to General Circular No. 22 dated 15th June 2020) General Circular No. 22 dated 15th June 2020) to scrutinise the votes cast electronically ("e-voting / remote e-voting") on the item of business set out in the Notice of Postal Ballot dated August, 08, 2020.
2. In compliance with the provisions of Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and Sections 108 and 110 of the Companies Act 2013 read with Rules 20 & 22 of the Companies (Management and Administration) Rules, 2014, the Company had provided Remote E-voting facility to cast vote on the resolution through the electronic voting platform of KFin Technologies Private Limited ("KFin").
3. In terms of the General Circular No.14/2020 dated 8th April 2020 read with General Circular No.17/2020 dated 13th April 2020 and General Circular No.22/2020 dated 15th June 2020 issued by the Ministry of Corporate Affairs, Government of India (the "MCA Circulars"), voting was done only by e-voting.
4. In terms of Regulation 47 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and pursuant to Rules 20 & 22 of the Companies (Management and Administration) Rules, 2014, advertisement was published by the Company in English Newspaper "Financial Express" and Marathi Newspaper "Loksatta" on August 4, 2020 requesting members of the Company to register their email addresses also on August 9, 2020 regarding notice of the postal ballot and informing about the completion of dispatch of Postal Ballot Notice and Forms and details of E-voting. Notice of Postal Ballot were sent electronically to those members who has registered their e-mail id with the company/depositories or depository participants.
5. The E-voting period remained open from Sunday, August 09, 2020 (9.00 A.M. IST) and ended on Monday, September 07, 2020 (5.00 P.M.) IST. During the period, Members of the Company holding share in physical and/or in dematerialised form, as on cut-off date i.e. Monday, August 03, 2020 were entitled to vote on the resolution set out in the Notice of Postal Ballot dated August 08, 2020.


